

## 7. Engineer's Report (2)



#### A. Canal C Project Update

- The District received two high bids on December 21, 2023
- A meeting was held with the low bidder, Rio-Bak, on January 16, 2024, to discuss ways to bring the cost down and the District performing a portion of the work
- Rio-Bak responded on February 13, 2024, offering to perform a third of the work
- A meeting will be scheduled for next week to discuss the best way to proceed for the District to get the most value

 The survey schedule has been pushed back two weeks until the end of February



#### D. Paving of Haynie Lane and Palm Beach Country Estates "Pink" Roads

- An Advertisement for Bids was published on February 4, 2024, for asphalt paving overlays of the following roadway segments totaling 2.45 miles:
  - Haynie Lane (south of 167th Place to Randolph Siding Road)
  - 145th Place North
  - 64th and 65th Way
  - 66th and 67th Trail North
  - 68th Drive North

Bids are due March 7, 2024



#### E. Busch Wildlife Sanctuary Update

- A site meeting with South Florida Water Management District staff, Busch Wildlife Sanctuary and their consultants, and South Indian River Water Control District was held on February 13, 2024. Alternative solutions were discussed.
- The next step is for Busch Wildlife Sanctuary's Engineer to run the calculations and propose a solution to both South Florida Water Management District and South Indian River Water Control District.
