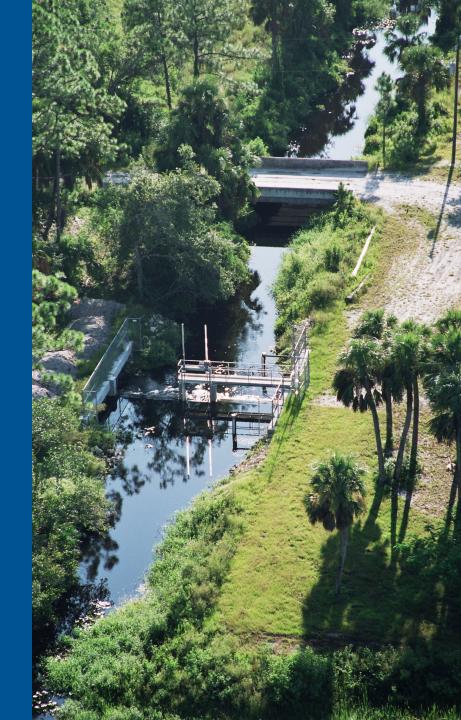



### Proposed Budget 2024/2025 - Highlights

#### **Internal Service Funds**

Distributable costs increased by \$195,500 (Included in the budgets below)

#### Special Revenue Funds (Water Control, Road Maintenance) & Capital Projects Funds

- Jupiter Farms An increase in acreage assessments of \$15 and decrease in parcel assessments of \$12
- Palm Beach Country Estates An increase in maintenance acreage assessments of \$5 and increase in debt parcel assessments of \$32
- Egret Landing, Jupiter Commerce Park An increase in maintenance acreage assessments of \$5
