This report is submitted in compliance with Florida Statute 218.415.

This report summarizes the District's investment results for the period April 1, 2012 to September 30, 2012. Outlined below are comments regarding recent market conditions, economic developments, anticipated investment conditions and District portfolio results.

As reported in the Wells Fargo Securities, September 24, Economics Group, "The Federal Reserve Bank of Chicago's National Activity Index (CFNAI) fell 0.75 points in August to -0.87, which marks the lowest level for this index since June 2009, when the economy was emerging from the Great Recession".

However, according to the September 25, Consumer Confidence Index- "expectations about the future economic condition sent consumer confidence Index up which rose a larger than expected 9.0 points as fears about soaring gasoline prices and the approaching fiscal cliff appear to have subsided somewhat. The expectation series jumped 12.6 points 83.7 in September, marking its highest reading since February. The rise in expectations mirrors the recent improvement in the stock market. "

Also, according to The Leading Economic Index (LEI), "Given the Fed's most recent aggressive easing move, we would expect to see the financial indicators in the LEI to continue to hold up. The question will be, whether the real economy represented by consumer, employment and production will follow. Given the recent performance it does not inspire confidence that it will."

For the six-month period ended September 30, 2012 benchmark three-month Treasury- Bill rates ranged between 0.075% and 0.100%.

The average balance of the District's investments for the six months ended September 30, 2012, was \$5,824,203 and earned an average of \$339 per month. Using benchmark three-month Treasury Bill rates as a target objective, the District's estimated portfolio rate of return for the period was .0086% per annum. The actual rate of return was .070%.

The following is a summary of activities and communications that were of significance during the month of November 2012:

I. CURRENT CAPITAL IMPROVEMENTS AND OTHER DISTRICT PROJECTS

- A. The District has received petitions from landowners to apply both OGEM and Asphalt on certain roadways within the District. The roads met the requirements to distribute a referendum to all benefited landowners. Pursuant to Board direction, staff prepared a referendum for the landowner proposed projects that was mailed August 3, 2012 with the request that the landowner submit their response to the District by September 5, 2012. On September 11, 2012, staff received the certification from the Supervisor of Elections on the results of the referendum. The majority of the landowners who voted on the following roadways were "in favor" of the proposed project for OGEM in Jupiter Farms (approximately 0.4 miles):
 - 127th Drive N. between 187th Place N. and Old Indiantown Grade
 - 90th Trail N. between 165th Place N. and 166th Way N.

In addition, the majority of the landowners who voted on the following roadways were "in favor" of the proposed project for asphalt in Palm Beach Country Estates (approximately 1.5 miles):

- 73rd Terrace N. between 155th Place N. and 159th Court N.
- 79th Terrace N. between 155th Place N. and 162nd Court N.
- 75th Way N between 163rd Court N. and 165th Street N.
- 77th Trail N. between 165th Street N. and 167th Court N.

A resolution to amend the Water Control Plan was presented to the Board of Supervisor's on October 18, 2012. As part of this resolution, staff has determined the cost estimate and the benefitted area for the project and is prepared to present this information at this month's Board meeting.

II. OPERATION AND MAINTENANCE

- A. A National Pollutant Discharge Elimination System (NPDES) Steering Committee meeting was held on November 14, 2012. Discussions were held on upcoming Water Quality Monitoring Plan revisions and the TMDL Program, including implications on costs in the next permit cycle which is scheduled to begin in March 2016. This year's Annual Report and the required standard operating procedures are currently being prepared. The next Steering Committee Meeting is scheduled for January 16, 2013 and the agenda includes a discussion of the 4th Year budget estimate.
- B. On January 24, 2008, staff met with Palm Beach County to discuss their plans for the Hatcher/Indiantown Joint Venture Property. Palm Beach County is in the planning and permitting stages of a proposed project to improve the natural areas of the property while expanding the water features. Since the January 2008 meeting, staff has participated in many meetings with Palm Beach County to evaluate the project. On February 10, 2011, a Board of Supervisors workshop was held to update the Board and public on the project.

In accordance with Board direction, staff submitted a letter of conceptual approval to Palm Beach County subject to satisfying the items that were discussed at the Board of Supervisors meeting. South Florida Water Management District (SFWMD) issued a permit for the project on July 5, 2011. Staff met with Palm Beach County on November 3, 2011 to discuss the status of the project and operation of the facilities. On February 9, 2012, staff received a draft operation plan for the Hatcher Property. Staff has reviewed the operation plan, but on May 10, 2012, Palm Beach County met with staff concerning a new proposal. At the May 17, 2012 Board Meeting, Palm Beach County presented their new proposal to the Board and staff.

Staff has attended a meeting on October 16, 2012 to review a revised plan with Palm Beach County. Staff has reviewed the plan and is prepared to update the Board at this month's meeting.

C. On May 1, 2012, staff met with Palm Beach County Parks and Recreation for Riverbend Park to discuss the extension of Canal 3 directly east into the park. Currently, Canal 3 goes east from Jupiter Farms Road and turns south along the District line into Riverbend Park. When it enters Riverbend Park, the canal continues through two 42-inch culverts in series before discharging into the ultimate discharge location. By extending the canal directly east instead of turning south, headloss may be reduced, which may improve flood protection.

Staff met with South Florida Water Management District for a pre-application meeting on July 10, 2012 to discuss any concerns that they may have with the project. Also, staff presented the project to the Loxahatchee River Management Coordinating Council on September 24, 2012 to inform them of the upcoming improvements and receive any comments.

Staff is also exploring grant opportunities and has been in contact with the Florida Division of Emergency Management (Division) on applying for grant funds through FEMA. Staff met with the Division on October 4, 2012 and is submitting additional information to the Division. In addition, a cultural resource study is being conducted on the area to assist in the Town of Jupiter permitting process. Staff continues to cooperate with Palm Beach County on this project. Staff is prepared to update the Board at this month's meeting.

- D. SFWMD continues to operate the G-160 structure to maintain flood protection and is committed to coordinating with, and monitoring water levels at the perimeter of some of the communities adjacent to and east of the Loxahatchee Slough to determine if there are impacts to the communities resulting from the increased water levels. The monitoring wells installed in April 2010 in SIRWCD's perimeter levee for Palm Beach Country Estates are measuring surface and groundwater water levels in conjunction with the operation of the G-160 structure. Well data has been collected through the beginning of October and an interim report for the period from April 2010 September 2012 is under preparation. The interim report should be ready for review by January 2013. A stakeholder meeting was held on October 16, 2012. SFWMD has requested stakeholder input with respect to the scope of work for analysis of the data for a final report, as well as quality assurance and quality control of the data for inclusion into the DBHydro database.
- E. The North Palm Beach County Part 1 Comprehensive Everglades Restoration Plan (CERP) Project has been renamed the Loxahatchee River Watershed Restoration Plan. The overall purposes of this project are to increase water supplies to the Grassy Waters Preserve and Loxahatchee Slough, improve flow to enhance hydroperiods in the Loxahatchee Slough, increase base flows to the Northwest Fork of the Loxahatchee River, and reduce high discharges to the Lake Worth Lagoon. Concerns with the project that were developed by the Project Delivery Team include:
 - 1) the cost benefit analysis for the L-8 reservoir
 - 2) connate seepage water management costs
 - 3) the project's purpose
 - 4) habitat units

In order to resolve concerns, the Army Corp of Engineers and SFWMD developed an additional modeling scope. The last schedule included Agency Technical Review in August, 2011, a revised Alternative Formulation Briefing to Corps management in February, 2012, and completion of an Alternative Formulation Briefing report in April, 2012. However, that schedule has now been pushed back indefinitely due to SFWMD's new program described below.

SFWMD's "Everglades Restoration Strategies" is a program that has been developed in order to address water quality-based effluent limits for Stormwater Treatment Areas to meet NPDES permitting requirements by EPA. As part of the program's Technical Plan, both STA expansions and Flow Equalization Basins (FEB) upstream of STAs are proposed. The plan includes designation of the L-8 Reservoir as a 45,000 ac-ft FEB for STAs 1W and 1E. As a "replacement feature", the plan proposes to acquire and construct replacement storage to capture flows from the western C-18 Basin in the Mecca vicinity and discharge those flows via "Flow-way 2"



(C-18 West Canal through C-18 and Loxahatchee Slough) to the Northwest Fork of the Loxahatchee River to meet Minimum Flows and Levels. Staff will continue to follow this project and provide updates to the Board.

F. The date for promulgation of numeric nutrient criteria (total nitrogen and total phosphorus) for lakes and flowing waters (fresh waters) was October 15, 2011; however, the date for South Florida waters, including canals, has been extended to coincide with the revised date for promulgation of numeric nutrient criteria for estuaries and coastal waters. The first notice of rulemaking for estuaries and coastal waters was expected to be November 14, 2011 with final promulgation expected on August 15, 2012.

Staff attended a meeting conducted by the Florida Department of Environmental Protection (FDEP) on their determination of numeric nutrient criteria for the estuaries and coastal systems on August 26, 2010 and on November 17, 2010. On November 14, 2010, Environmental Protection Agency (EPA) approved the numeric nutrient criteria for fresh water and lakes. On September 29, 2011, FDEP published a draft Florida Administrative Code (F.A.C.) Chapter 62-302 regarding nutrient standards. Staff is reviewing these standards as they affect the District. The draft F.A.C. appeared before the Florida Environmental Regulation Commission (ERC). On December 8, 2011, the Florida ERC passed the Florida's numeric nutrient criteria, which include the following:

- an amendment to provide that narrative criteria will continue to apply to ditches, canals and urban storm water conveyances
- an amendment intended to limit the ability of EPA to pick and choose which provisions of the Florida rules to accept or reject.

An administrative challenge to the proposed rules has been filed by Earthjustice prior to their adoption on December 8, 2011. On June 7, 2012, an administrative law judge upheld the state's proposed new water quality rules. The rules were required ratification by the Florida Legislature, but Governor Rick Scott signed HB 7051 waiving legislative ratification of the proposed rules. After FDEP notifies the EPA of the judge's decision, EPA will have 60 days to approve the state rules and then would have to withdraw the Federal rule for the state rules to take effect.

A notice was filed in the Federal Register stating that the EPA is finalizing an extension of the July 6, 2012, effective date of the EPA NNC for six months to January 6, 2013. This will allow the EPA to review the Florida ERC approved numeric nutrient criteria. Staff has attended various workshops concerning the development of the numeric nutrient criteria and will continue to monitor the development of these criteria.

On May 15, 2012, staff attended a public workshop on Triennial Review of State Surface Water Quality Standards. This review is required by the Federal Clean Water Act to publically review, and update as necessary, Florida's water quality standards. Pursuant to federal regulations, this review is expected to happen every three years. The topics that were reviewed were Human Health-Based Criteria and Dissolved Oxygen Criteria.

On November 1, 2012, staff attended a public meeting on the South Florida Canal Aquatic Life Study being conducted by FDEP. The study objectives are to: (1) assess aquatic life in South Florida canals; (2) determine interrelationships between aquatic life in canals and other variables that affect that aquatic life; (3) evaluate the differences in conditions for South Florida canals; and (4) collect information that can be used to guide management decisions. The study is to be used as a guide in developing numeric nutrient criteria for canals.

G. On June 29, 2012, the EPA published a public notice of availability on the proposed Total Maximum Daily Loads (TMDLs) for waters and pollutants in the State of Florida. This notice included the proposed TMDL on the Southwest Fork of the Loxahatchee River and the C-18 Canal. The TMDL is for nutrients and dissolved oxygen and effects Palm Beach Country Estates, Jupiter Park of Commerce, and Egret Landing. Written comments are requested within 60 days of the notice. Staff is currently reviewing the proposed TMDL.

In addition, on July 6, 2012, FDEP announced a draft statewide TMDL for mercury and has published the document for review. Written comments will be accepted through August 27th, 2012 for the review of this document. Staff is currently reviewing this TMDL.

- H. Our office continues to monitor and participate in the activities of the Loxahatchee River Ecosystem Management Committee, the Loxahatchee River Initiative, and the Loxahatchee River Management Coordinating Council.
- I. We continue to receive, review, and comment on various permit applications for projects to be constructed within the District.
- J. We continue to provide engineering assistance to the General Manager, as needed, on operation and maintenance items, as well as landowner requests, utility requests, and inquiries from other governmental entities on issues that involve engineering support.

Routine Business

- 1. The total assessment received through August 31st, 2012 was \$5,252,601 (including tax sale receipts). No additional assessment are due for 2011/12 Fiscal Year. The budgeted assessments were \$5,243,000.
- 2. The District is scheduled to receive the first distribution of the 2012/2013 assessment receipts from the Palm Beach County Tax Collector on November 8, 2012.
- 3. We have opened up a general and payroll checking accounts at Regions Bank. We will be implementing direct deposits of payroll checks on the next payroll. A pretest of the system was run with no exceptions. Following the implementation of this system we will also be implementing positive pay for the general operating account. Positive pay is an anti-check fraud system whereby we will notify the bank the name, check number and amount of each check that will be issued. The bank then verifies that a tendered check is on the list prior to paying it.
- 4. We will be working with the District's auditors, Grau & Company, on the audit for the fiscal year ending September 30, 2012.
- 5. The District's year end was September 30, 2012. Since we are in the process of closing the books, a financial report has not been prepared. As part of this effort we have reviewed the budgets of all of the funds and have developed a number of budget amendments for consideration by the Board. Most of the budget amendments are housekeeping in nature, to bring the budget in line with actual activity. As discussed in the attached memo there are a few items that do involve transfers between funds rather than adjusting line items within a given fund.
- 6. Following the Board's direction we will be sending our report to the District's Public Information Officer for uploading to the web-site.

The Board of Supervisors will be asked to consider and approve the following budget amendments. Most of these amendments are needed due to transactions not foreseen or expected when this budget was adopted in July 2011. As an example, the District received over \$500,000 from the Town of Jupiter from the Interlocal agreement including the extension that was approved earlier in the fiscal year. Most of these amendments are within line items of a particular fund.

However there are a number of amendments that call for transfers between funds and as such deserve to be noted.

An amendment to Fund 140, Road maintenance PBCE increasing the transfer out account for \$30,000 and the transfer in account for fund 110 Water control East basin for \$5,000 and fund 185 PBCE Park Maintenance for \$25,000. Both of these amendments are necessary to cover fund deficits. The fund deficit in fund 110 is primarily due to the spend-down of reserves when we were paying our required share of the NRCS grants. Over the years the assessment rate has been increased in this fund to restore the fund equity to a reasonable amount. New accounting rules now dictate that the fund deficits be eliminated thus requiring this transfer. I expect that this transfer will be reversed in the next fiscal year. The deficit in fund 185 is due to the construction of the parking lot. A few months ago the Board did approve a transfer of \$25,000. Unfortunately, there was another bill from Lynch that was not included in the analysis. This will be the last transfer for this fund.

The second amendment requiring a transfer is to transfer \$42,000 from fund 215, Section 9 Phases II Debt Service fund to Fund 216 Section 9 Phase IIA Debt service Fund in the amount of \$11,000 and Fund 217, Section 9 Phase IIB in the amount of \$31,000. Phase II was split into a Phase IIA and a Phase IIB so the same parcels in the aggregate that are in Phase II are in Phase IIA and Phase IIB. On August 1, 2012 the final payment on the Phase II debt was made. The fund has approximately \$42,000 remaining in it after this final payment. Over the past few years there has been some softness in the collection of assessments from the benefitted area (Jupiter Commerce Park). In anticipation of this occurrence, I had built up substantial reserves so as to avoid a default or some other deleterious event. However, this past fiscal year some of the delinquent properties were sold at tax sale, with the District receiving its unpaid taxes, leaving more money in the fund than was needed to satisfy the debt.

There remain outstanding debt payments on Phase IIA (2012-13 being the last year) and Phase IIB with two years to go. The surplus on the fund 215 is being allocated to the two other funds in proportion to the original allocation of assessments.

Of final note is the budget amendment for Fund 229, Egret Landing Debt Service. These amendments are due to the refinancing of the Bonds in December, 2011. At the time the Board authorized the transaction, the budget amendment was also authorized, however a formal document reflecting the actual accounts affected was not presented.

The following is a summary of activities and communications that were of significance during the month of October 2012:

I. CURRENT CAPITAL IMPROVEMENTS AND OTHER DISTRICT PROJECTS

- A. The District has received petitions from landowners to apply both OGEM and Asphalt on certain roadways within the District. The roads met the requirements to distribute a referendum to all benefited landowners. Pursuant to Board direction, staff prepared a referendum for the landowner proposed projects that was mailed August 3, 2012 with the request that the landowner submit their response to the District by September 5, 2012. On September 11, 2012, staff received the certification from the Supervisor of Elections on the results of the referendum. The majority of the landowners who voted on the following roadways were "in favor" of the proposed project for OGEM in Jupiter Farms (approximately 0.4 miles):
 - 127th Drive N. between 187th Place N. and Old Indiantown Grade
 - 90th Trail N. between 165th Place N. and 166th Way N.

In addition, the majority of the landowners who voted on the following roadways were "in favor" of the proposed project for asphalt in Palm Beach Country Estates (approximately 1.5 miles):

- 73rd Terrace N. between 155th Place N. and 159th Court N.
- 79th Terrace N. between 155th Place N. and 162nd Court N.
- 75th Way N between 163rd Court N. and 165th Street N.
- 77th Trail N. between 165th Street N. and 167th Court N.

II. OPERATION AND MAINTENANCE

A. A National Pollutant Discharge Elimination System (NPDES) Steering Committee meeting was held on September 19, 2012. A discussion was held on the Stormwater Management Plan components and Standard Operating Procedures to be completed



in this year's Annual Report. In addition, a Public Education update included a television advertisement which will run from January through April and a Florida Yards and Neighborhood brochure to be printed and distributed.

The next Steering Committee Meeting is scheduled for November 14, 2012 and the agenda includes a discussion of the TMDL Program and proposed water quality monitoring requirements for outfalls into TMDL water bodies.

B. On January 24, 2008, staff met with Palm Beach County to discuss their plans for the Hatcher/Indiantown Joint Venture Property. Palm Beach County is in the planning and permitting stages of a proposed project to improve the natural areas of the property while expanding the water features. Since the January 2008 meeting, staff has participated in many meetings with Palm Beach County to evaluate the project. On February 10, 2011, a Board of Supervisors workshop was held to update the Board and public on the project.

In accordance with Board direction, staff submitted a letter of conceptual approval to Palm Beach County subject to satisfying the items that were discussed at the Board of Supervisors meeting. South Florida Water Management District (SFWMD) issued a permit for the project on July 5, 2011. Staff recently met with Palm Beach County on November 3, 2011 to discuss the status of the project and operation of the facilities. On February 9, 2012, staff received a draft operation plan for the Hatcher Property. Staff has reviewed the operation plan, but on May 10, 2012, Palm Beach County met with staff concerning a new proposal. At the May 17, 2012 Board Meeting, Palm Beach County presented their new proposal to the Board and staff.

Currently, staff was asked to attend a meeting on October 16, 2012 to review a revised plan with Palm Beach County. Staff continues to coordinate with Palm Beach County on this project.

C. On May 1, 2012, staff met with Palm Beach County Parks and Recreation for Riverbend Park to discuss the extension of Canal 3 directly east into the park. Currently, Canal 3 goes east from Jupiter Farms Road and turns south along the District line into Riverbend Park. When it enters Riverbend Park, the canal continues through two 42-inch culverts in series before discharging into the ultimate discharge location. By extending the canal directly east instead of turning south, headloss can be reduced, which improve flood protection.

Staff met with South Florida Water Management District for a pre-application meeting on July 10, 2012 to discuss any concerns that they may have with the project. Also, staff presented the project to the Loxahatchee River Management Coordinating Council on September 24, 2012 to inform them of the upcoming improvements and receive any comments.

Staff is also exploring grant opportunities and has been in contact with the Florida Division of Emergency Management on applying for grant funds through FEMA. Staff met with the Division on October 4, 2012 and is submitting additional information to the Division. In addition, a cultural resource study is being conducted on the area to assist in the Town of Jupiter permitting process. Staff continues to cooperate with Palm Beach County on this project.

- D. SFWMD continues to operate the G-160 structure to maintain flood protection and is committed to coordinating with, and monitoring water levels at the perimeter of some of the communities adjacent to and east of the Loxahatchee Slough to determine if there are impacts to the communities resulting from the increased water levels. The monitoring wells installed in April 2010 in SIRWCD's perimeter levee for Palm Beach Country Estates are measuring surface and groundwater water levels in conjunction with the operation of the G-160 structure. Well data has been collected through the end of September and an interim report is under preparation. SFWMD has requested stakeholder input with respect to the scope of work for analysis of the data for a final report, as well as QA/QC of the data for inclusion into the DBHydro database. A stakeholder meeting has been scheduled for October 16, 2012.
- E. The North Palm Beach County Part 1 Comprehensive Everglades Restoration Plan (CERP) Project has been renamed the Loxahatchee River Watershed Restoration Plan. The overall purposes of this project are to increase water supplies to the Grassy Waters Preserve and Loxahatchee Slough, improve flow to enhance hydroperiods in the Loxahatchee Slough, increase base flows to the Northwest Fork of the Loxahatchee River, and reduce high discharges to the Lake Worth Lagoon. Concerns with the project that were developed by the Project Delivery Team include:
 - 1) the cost benefit analysis for the L-8 reservoir
 - 2) connate seepage water management costs
 - 3) the project's purpose
 - 4) habitat units

In order to resolve concerns, the Army Corp of Engineers and SFWMD developed an additional modeling scope. The last schedule included Agency Technical Review in August, 2011, a revised Alternative Formulation Briefing to Corps management in February, 2012, and completion of an Alternative Formulation Briefing report in April, 2012. However, that schedule has now been pushed back indefinitely due to SFWMD's new program described below.

SFWMD's "Everglades Restoration Strategies" is a program that has been developed in order to address water quality-based effluent limits for Stormwater Treatment Areas to meet NPDES permitting requirements by EPA. As part of the program's Technical Plan, both STA expansions and Flow Equalization Basins (FEB) upstream of STAs are proposed. The plan includes designation of the L-8 Reservoir as a 45,000 ac-ft FEB for STAs 1W and 1E. As a "replacement feature", the plan proposes to acquire and construct replacement storage to capture flows from the western C-18 Basin in the Mecca vicinity and discharge those flows via "Flow-way 2" (C-18 West Canal through C-18 and Loxahatchee Slough) to the Northwest Fork of the Loxahatchee River to meet Minimum Flows and Levels.

Staff will continue to follow future developments and how they may impact the District.

F. The date for promulgation of numeric nutrient criteria (total nitrogen and total phosphorus) for lakes and flowing waters (fresh waters) was October 15, 2011; however, the date for South Florida waters, including canals, has been extended to coincide with the revised date for promulgation of numeric nutrient criteria for

estuaries and coastal waters. The first notice of rulemaking for estuaries and coastal waters was expected to be November 14, 2011 with final promulgation expected on August 15, 2012.

Staff attended a meeting conducted by the Florida Department of Environmental Protection (FDEP) on their determination of numeric nutrient criteria for the estuaries and coastal systems on August 26, 2010 and on November 17, 2010. On November 14, 2010, Environmental Protection Agency (EPA) approved the numeric nutrient criteria for fresh water and lakes. On September 29, 2011, FDEP published a draft Florida Administrative Code (F.A.C.) Chapter 62-302 regarding nutrient standards. Staff is reviewing these standards as they affect the District. The draft F.A.C. appeared before the Florida Environmental Regulation Commission (ERC). On December 8, 2011, the Florida Environmental Regulation Commission passed the Florida's numeric nutrient criteria, which include the following:

- an amendment to provide that narrative criteria will continue to apply to ditches, canals and urban storm water conveyances
- an amendment intended to limit the ability of EPA to pick and choose which provisions of the Florida rules to accept or reject.

An administrative challenge to the proposed rules has been filed by Earthjustice prior to their adoption on December 8, 2011. On June 7, 2012, an administrative law judge upheld the state's proposed new water quality rules. The rules were required ratification by the Florida Legislature, but Governor Rick Scott signed HB 7051 waiving legislative ratification of the proposed rules. After FDEP notifies the EPA of the judge's decision, EPA will have 60 days to approve the state rules and then would have to withdraw the Federal rule for the state rules to take effect.

A notice was filed in the Federal Register stating that the EPA is finalizing an extension of the July 6, 2012, effective date of the EPA NNC for six months to January 6, 2012. This will allow the EPA to review the Florida ERC approved numeric nutrient criteria. Staff has attended various workshops concerning the development of the numeric nutrient criteria and will continue to monitor the development of these criteria.

On May 15, 2012, staff attended a public workshop on Triennial Review of State Surface Water Quality Standards. This review is required by the Federal Clean Water Act to publically review, and update as necessary, Florida's water quality standards. Pursuant to federal regulations, this review is expected to happen every tree years. The topics that were reviewed were Human Health-Based Criteria and Dissolved Oxygen Criteria.

G. On June 29, 2012, the EPA published a public notice of availability on the proposed Total Maximum Daily Loads (TMDLs) for waters and pollutants in the State of Florida. This notice included the proposed TMDL on the Southwest Fork of the Loxahatchee River and the C-18 Canal. The TMDL is for nutrients and dissolved oxygen and effects Palm Beach Country Estates, Jupiter Park of Commerce, and Egret Landing. Written comments are requested within 60 days of the notice. Staff is currently reviewing the proposed TMDL.

In addition, on July 6, 2012, FDEP announced a draft statewide TMDL for mercury and has published the document for review. Written comments will be accepted through August 27th, 2012 for the review of this document. Staff is currently reviewing this TMDL.

The following is a summary of activities and communications that were of significance during the months of December 2012 and January 2013:

I. CURRENT CAPITAL IMPROVEMENTS AND OTHER DISTRICT PROJECTS

- A. The District has received petitions from landowners to apply both OGEM and Asphalt on certain roadways within the District. The roads met the requirements to distribute a referendum to all benefited landowners. Pursuant to Board direction, staff prepared a referendum for the landowner proposed projects that was mailed August 3, 2012 with the request that the landowner submit their response to the District by September 5, 2012. On September 11, 2012, staff received the certification from the Supervisor of Elections on the results of the referendum. The majority of the landowners who voted on the following roadways were "in favor" of the proposed project for OGEM in Jupiter Farms (approximately 0.4 miles):
 - 127th Drive N. between 187th Place N. and Old Indiantown Grade
 - 90th Trail N. between 165th Place N. and 166th Way N.

In addition, the majority of the landowners who voted on the following roadways were "in favor" of the proposed project for asphalt in Palm Beach Country Estates (approximately 1.5 miles):

- 73rd Terrace N. between 155th Place N. and 159th Court N.
- 79th Terrace N. between 155th Place N. and 162nd Court N.
- 75th Way N between 163rd Court N. and 165th Street N.
- 77th Trail N. between 165th Street N. and 167th Court N.

A resolution to amend the Water Control Plan was presented to the Board of Supervisor's on October 18, 2012. As part of this resolution, staff has determined the cost estimate and the benefitted area for the project. Currently, staff has been directed to suspend work on the proposed Plan of Improvements pending the outcome of a Board of Supervisors workshop.

On January 10, 2013, a workshop was held to discuss the landowner initiated roadway program and other items. Many topics were discussed at this meeting and some required further evaluation by the Board and staff. Staff is currently working on these items in preparation for another workshop that will be scheduled in the near future.

II. OPERATION AND MAINTENANCE

- A. There has not been a National Pollutant Discharge Elimination System (NPDES) Steering Committee meeting since our last report. This year's Annual Report and the required standard operating procedures are currently being finalized for submittal. The next Steering Committee Meeting is scheduled for January 16, 2013 and the agenda includes a discussion of EPA proposed water quality regulations, including a Total Maximum Daily Load (TMDL) for the Lake Worth Lagoon and tributaries and Numeric Nutrient Criteria for south Florida canals and estuaries.
- B. On January 24, 2008, staff met with Palm Beach County to discuss their plans for the Hatcher/Indiantown Joint Venture Property. Palm Beach County is in the planning and permitting stages of a proposed project to improve the natural areas of the property while expanding the water features. Since the January 2008 meeting, staff has participated in many meetings with Palm Beach County to evaluate the project. On February 10, 2011, a Board of Supervisors workshop was held to update the Board and public on the project.

In accordance with Board direction, staff submitted a letter of conceptual approval to Palm Beach County subject to satisfying the items that were discussed at the Board of Supervisors meeting. South Florida Water Management District (SFWMD) issued a permit for the project on July 5, 2011. Staff met with Palm Beach County on November 3, 2011 to discuss the status of the project and operation of the facilities. On February 9, 2012, staff received a draft operation plan for the Hatcher Property. Staff has reviewed the operation plan, but on May 10, 2012, Palm Beach County met with staff concerning a new proposal. At the May 17, 2012 Board Meeting, Palm Beach County presented their new proposal to the Board and staff.

Staff attended a meeting on October 16, 2012 to review a revised plan with Palm Beach County. Palm Beach County attended the November 29, 2012 Board Meeting to present this revised plan to the Board of Supervisors. At that meeting, the Board of Supervisors authorized and directed staff to prepare a letter of conceptual approval to Palm Beach County on the revised plan.

C. On May 1, 2012, staff met with Palm Beach County Parks and Recreation for Riverbend Park to discuss the extension of Canal 3 directly east into the park. Currently, Canal 3 goes east from Jupiter Farms Road and turns south along the District line into Riverbend Park. When it enters Riverbend Park, the canal continues through two 42-inch culverts in series before discharging into the ultimate discharge location. By extending the canal directly east instead of turning south, headloss may be reduced, which may improve flood protection.

Staff met with South Florida Water Management District for a pre-application meeting on July 10, 2012 to discuss any concerns that they may have with the project. Also,

staff presented the project to the Loxahatchee River Management Coordinating Council on September 24, 2012 to inform them of the upcoming improvements and receive any comments.

Staff has submitted several permit applications and a cultural resource study has been conducted on the area to assist in the Town of Jupiter permitting process. Staff is currently working on several responses for additional information to the permitting agencies. In addition, staff is working to finalize a contract with a contractor for the work which is required for the Town of Jupiter permit and is continuing to explore grant opportunities.

- D. SFWMD continues to operate the G-160 structure to maintain flood protection and is committed to coordinating with, and monitoring water levels at the perimeter of some of the communities adjacent to and east of the Loxahatchee Slough to determine if there are impacts to the communities resulting from the increased water levels. The monitoring wells installed in April 2010 in SIRWCD's perimeter levee for Palm Beach Country Estates are measuring surface and groundwater water levels in conjunction with the operation of the G-160 structure. Well data has been collected through the beginning of October and an interim report for the period from April 2010 September 2012 is under preparation. The interim report should be ready for review by January 2013. A stakeholder meeting was held on October 16, 2012. SFWMD has requested stakeholder input with respect to the scope of work for analysis of the data for a final report, as well as quality assurance and quality control of the data for inclusion into the DBHydro database.
- E. The North Palm Beach County Part 1 Comprehensive Everglades Restoration Plan (CERP) Project has been renamed the Loxahatchee River Watershed Restoration Plan. The overall purposes of this project are to increase water supplies to the Grassy Waters Preserve and Loxahatchee Slough, improve flow to enhance hydroperiods in the Loxahatchee Slough, increase base flows to the Northwest Fork of the Loxahatchee River, and reduce high discharges to the Lake Worth Lagoon. Concerns with the project that were developed by the Project Delivery Team include:
 - 1) the cost benefit analysis for the L-8 reservoir
 - 2) connate seepage water management costs
 - 3) the project's purpose
 - 4) habitat units

In order to resolve concerns, the Army Corp of Engineers and SFWMD developed an additional modeling scope. The last schedule included Agency Technical Review in August, 2011, a revised Alternative Formulation Briefing to Corps management in February, 2012, and completion of an Alternative Formulation Briefing report in April, 2012. However, that schedule has now been pushed back indefinitely due to SFWMD's new program described below.

SFWMD's "Everglades Restoration Strategies" is a program that has been developed in order to address water quality-based effluent limits for Stormwater Treatment Areas to meet NPDES permitting requirements by EPA. As part of the program's Technical Plan, both STA expansions and Flow Equalization Basins (FEB) upstream of STAs are proposed. The plan includes designation of the L-8 Reservoir

as a 45,000 ac-ft FEB for STAs 1W and 1E. As a "replacement feature", the plan proposes to acquire and construct replacement storage to capture flows from the western C-18 Basin in the Mecca vicinity and discharge those flows via "Flow-way 2" (C-18 West Canal through C-18 and Loxahatchee Slough) to the Northwest Fork of the Loxahatchee River to meet Minimum Flows and Levels. Staff will continue to follow this project and provide updates to the Board.

F. The date for promulgation of numeric nutrient criteria (total nitrogen and total phosphorus) for lakes and flowing waters (fresh waters) was October 15, 2011; however, the date for South Florida waters, including canals, has been extended to coincide with the revised date for promulgation of numeric nutrient criteria for estuaries and coastal waters. The first notice of rulemaking for estuaries and coastal waters was expected to be November 14, 2011 with final promulgation expected on August 15, 2012.

Staff attended a meeting conducted by the Florida Department of Environmental Protection (FDEP) on their determination of numeric nutrient criteria for the estuaries and coastal systems on August 26, 2010 and on November 17, 2010. On November 14, 2010, Environmental Protection Agency (EPA) approved the numeric nutrient criteria for fresh water and lakes. On September 29, 2011, FDEP published a draft Florida Administrative Code (F.A.C.) Chapter 62-302 regarding nutrient standards. Staff is reviewing these standards as they affect the District. The draft F.A.C. appeared before the Florida Environmental Regulation Commission (ERC). On December 8, 2011, the Florida ERC passed the Florida's numeric nutrient criteria, which include the following:

- an amendment to provide that narrative criteria will continue to apply to ditches, canals and urban storm water conveyances
- an amendment intended to limit the ability of EPA to pick and choose which provisions of the Florida rules to accept or reject.

An administrative challenge to the proposed rules has been filed by Earthjustice prior to their adoption on December 8, 2011. On June 7, 2012, an administrative law judge upheld the state's proposed new water quality rules. The rules were required ratification by the Florida Legislature, but Governor Rick Scott signed HB 7051 waiving legislative ratification of the proposed rules. After FDEP notifies the EPA of the judge's decision, EPA will have 60 days to approve the state rules and then would have to withdraw the Federal rule for the state rules to take effect.

A notice was filed in the Federal Register stating that the EPA is finalizing an extension of the July 6, 2012, effective date of the EPA NNC for six months to January 6, 2013. This will allow the EPA to review the Florida ERC approved numeric nutrient criteria. Staff has attended various workshops concerning the development of the numeric nutrient criteria and will continue to monitor the development of these criteria.

On November 1, 2012, staff attended a public meeting on the South Florida Canal Aquatic Life Study being conducted by FDEP. It included the Manager of Operations' and the District Engineer's annual reports, as well as the Roadway Improvement Project referenda results, Gregory Gell's 20 year service recognition, David Beane's award for service, Board of Supervisor election results, 2012-2013 Budget approval and Stormwater Education Corner.

The overall re-design and updating of the SIRWCD website continues and will include a new look, better visibility and functionality, new information, NPDES educational aspects and more.

We continue to work with Mr. Rice and the Manager of Operations on a regular basis, as well as supplying supervisors and members of the staff newspaper clippings on SIRWCD related stories, articles on roads, drainage and other issues of interest in Palm Beach County and Florida, as well as nationally. As of the beginning of the year we began emailing the news clippings to the supervisors and staff. This will help save on paper and postage.

The following is a summary of activities and communications that were of significance during the months of December 2012 and January 2013:

I. CURRENT CAPITAL IMPROVEMENTS AND OTHER DISTRICT PROJECTS

- A. The District has received petitions from landowners to apply both OGEM and Asphalt on certain roadways within the District. The roads met the requirements to distribute a referendum to all benefited landowners. Pursuant to Board direction, staff prepared a referendum for the landowner proposed projects that was mailed August 3, 2012 with the request that the landowner submit their response to the District by September 5, 2012. On September 11, 2012, staff received the certification from the Supervisor of Elections on the results of the referendum. The majority of the landowners who voted on the following roadways were "in favor" of the proposed project for OGEM in Jupiter Farms (approximately 0.4 miles):
 - 127th Drive N. between 187th Place N. and Old Indiantown Grade
 - 90th Trail N. between 165th Place N. and 166th Way N.

In addition, the majority of the landowners who voted on the following roadways were "in favor" of the proposed project for asphalt in Palm Beach Country Estates (approximately 1.5 miles):

- 73rd Terrace N. between 155th Place N. and 159th Court N.
- 79th Terrace N. between 155th Place N. and 162nd Court N.
- 75th Way N between 163rd Court N. and 165th Street N.
- 77th Trail N. between 165th Street N. and 167th Court N.

A resolution to amend the Water Control Plan was presented to the Board of Supervisor's on October 18, 2012. As part of this resolution, staff has determined the cost estimate and the benefitted area for the project. Currently, staff has been directed to suspend work on the proposed Plan of Improvements pending the outcome of a Board of Supervisors workshop.

On January 10, 2013, a workshop was held to discuss the landowner initiated roadway program and other items. Many topics were discussed at this meeting and some required further evaluation by the Board and staff. Staff is currently working on these items in preparation for another workshop that will be scheduled in the near future.

II. OPERATION AND MAINTENANCE

- A. There has not been a National Pollutant Discharge Elimination System (NPDES) Steering Committee meeting since our last report. This year's Annual Report and the required standard operating procedures are currently being finalized for submittal. The next Steering Committee Meeting is scheduled for January 16, 2013 and the agenda includes a discussion of EPA proposed water quality regulations, including a Total Maximum Daily Load (TMDL) for the Lake Worth Lagoon and tributaries and Numeric Nutrient Criteria for south Florida canals and estuaries.
- B. On January 24, 2008, staff met with Palm Beach County to discuss their plans for the Hatcher/Indiantown Joint Venture Property. Palm Beach County is in the planning and permitting stages of a proposed project to improve the natural areas of the property while expanding the water features. Since the January 2008 meeting, staff has participated in many meetings with Palm Beach County to evaluate the project. On February 10, 2011, a Board of Supervisors workshop was held to update the Board and public on the project.

In accordance with Board direction, staff submitted a letter of conceptual approval to Palm Beach County subject to satisfying the items that were discussed at the Board of Supervisors meeting. South Florida Water Management District (SFWMD) issued a permit for the project on July 5, 2011. Staff met with Palm Beach County on November 3, 2011 to discuss the status of the project and operation of the facilities. On February 9, 2012, staff received a draft operation plan for the Hatcher Property. Staff has reviewed the operation plan, but on May 10, 2012, Palm Beach County met with staff concerning a new proposal. At the May 17, 2012 Board Meeting, Palm Beach County presented their new proposal to the Board and staff.

Staff attended a meeting on October 16, 2012 to review a revised plan with Palm Beach County. Palm Beach County attended the November 29, 2012 Board Meeting to present this revised plan to the Board of Supervisors. At that meeting, the Board of Supervisors authorized and directed staff to prepare a letter of conceptual approval to Palm Beach County on the revised plan.

C. On May 1, 2012, staff met with Palm Beach County Parks and Recreation for Riverbend Park to discuss the extension of Canal 3 directly east into the park. Currently, Canal 3 goes east from Jupiter Farms Road and turns south along the District line into Riverbend Park. When it enters Riverbend Park, the canal continues through two 42-inch culverts in series before discharging into the ultimate discharge location. By extending the canal directly east instead of turning south, headloss may be reduced, which may improve flood protection.

Staff met with South Florida Water Management District for a pre-application meeting on July 10, 2012 to discuss any concerns that they may have with the project. Also,

staff presented the project to the Loxahatchee River Management Coordinating Council on September 24, 2012 to inform them of the upcoming improvements and receive any comments.

Staff has submitted several permit applications and a cultural resource study has been conducted on the area to assist in the Town of Jupiter permitting process. Staff is currently working on several responses for additional information to the permitting agencies. In addition, staff is working to finalize a contract with a contractor for the work which is required for the Town of Jupiter permit and is continuing to explore grant opportunities.

- D. SFWMD continues to operate the G-160 structure to maintain flood protection and is committed to coordinating with, and monitoring water levels at the perimeter of some of the communities adjacent to and east of the Loxahatchee Slough to determine if there are impacts to the communities resulting from the increased water levels. The monitoring wells installed in April 2010 in SIRWCD's perimeter levee for Palm Beach Country Estates are measuring surface and groundwater water levels in conjunction with the operation of the G-160 structure. Well data has been collected through the beginning of October and an interim report for the period from April 2010 September 2012 is under preparation. The interim report should be ready for review by January 2013. A stakeholder meeting was held on October 16, 2012. SFWMD has requested stakeholder input with respect to the scope of work for analysis of the data for a final report, as well as quality assurance and quality control of the data for inclusion into the DBHydro database.
- E. The North Palm Beach County Part 1 Comprehensive Everglades Restoration Plan (CERP) Project has been renamed the Loxahatchee River Watershed Restoration Plan. The overall purposes of this project are to increase water supplies to the Grassy Waters Preserve and Loxahatchee Slough, improve flow to enhance hydroperiods in the Loxahatchee Slough, increase base flows to the Northwest Fork of the Loxahatchee River, and reduce high discharges to the Lake Worth Lagoon. Concerns with the project that were developed by the Project Delivery Team include:
 - 1) the cost benefit analysis for the L-8 reservoir
 - 2) connate seepage water management costs
 - 3) the project's purpose
 - 4) habitat units

In order to resolve concerns, the Army Corp of Engineers and SFWMD developed an additional modeling scope. The last schedule included Agency Technical Review in August, 2011, a revised Alternative Formulation Briefing to Corps management in February, 2012, and completion of an Alternative Formulation Briefing report in April, 2012. However, that schedule has now been pushed back indefinitely due to SFWMD's new program described below.

SFWMD's "Everglades Restoration Strategies" is a program that has been developed in order to address water quality-based effluent limits for Stormwater Treatment Areas to meet NPDES permitting requirements by EPA. As part of the program's Technical Plan, both STA expansions and Flow Equalization Basins (FEB) upstream of STAs are proposed. The plan includes designation of the L-8 Reservoir

as a 45,000 ac-ft FEB for STAs 1W and 1E. As a "replacement feature", the plan proposes to acquire and construct replacement storage to capture flows from the western C-18 Basin in the Mecca vicinity and discharge those flows via "Flow-way 2" (C-18 West Canal through C-18 and Loxahatchee Slough) to the Northwest Fork of the Loxahatchee River to meet Minimum Flows and Levels. Staff will continue to follow this project and provide updates to the Board.

F. The date for promulgation of numeric nutrient criteria (total nitrogen and total phosphorus) for lakes and flowing waters (fresh waters) was October 15, 2011; however, the date for South Florida waters, including canals, has been extended to coincide with the revised date for promulgation of numeric nutrient criteria for estuaries and coastal waters. The first notice of rulemaking for estuaries and coastal waters was expected to be November 14, 2011 with final promulgation expected on August 15, 2012.

Staff attended a meeting conducted by the Florida Department of Environmental Protection (FDEP) on their determination of numeric nutrient criteria for the estuaries and coastal systems on August 26, 2010 and on November 17, 2010. On November 14, 2010, Environmental Protection Agency (EPA) approved the numeric nutrient criteria for fresh water and lakes. On September 29, 2011, FDEP published a draft Florida Administrative Code (F.A.C.) Chapter 62-302 regarding nutrient standards. Staff is reviewing these standards as they affect the District. The draft F.A.C. appeared before the Florida Environmental Regulation Commission (ERC). On December 8, 2011, the Florida ERC passed the Florida's numeric nutrient criteria, which include the following:

- an amendment to provide that narrative criteria will continue to apply to ditches, canals and urban storm water conveyances
- an amendment intended to limit the ability of EPA to pick and choose which provisions of the Florida rules to accept or reject.

An administrative challenge to the proposed rules has been filed by Earthjustice prior to their adoption on December 8, 2011. On June 7, 2012, an administrative law judge upheld the state's proposed new water quality rules. The rules were required ratification by the Florida Legislature, but Governor Rick Scott signed HB 7051 waiving legislative ratification of the proposed rules. After FDEP notifies the EPA of the judge's decision, EPA will have 60 days to approve the state rules and then would have to withdraw the Federal rule for the state rules to take effect.

A notice was filed in the Federal Register stating that the EPA is finalizing an extension of the July 6, 2012, effective date of the EPA NNC for six months to January 6, 2013. This will allow the EPA to review the Florida ERC approved numeric nutrient criteria. Staff has attended various workshops concerning the development of the numeric nutrient criteria and will continue to monitor the development of these criteria.

On May 15, 2012, staff attended a public workshop on Triennial Review of State Surface Water Quality Standards. This review is required by the Federal Clean Water Act to publically review, and update as necessary, Florida's water quality standards. Pursuant to federal regulations, this review is expected to happen every

three years. The topics that were reviewed were Human Health-Based Criteria and Dissolved Oxygen Criteria.

On November 1, 2012, staff attended a public meeting on the South Florida Canal Aquatic Life Study being conducted by FDEP. The study objectives are to: (1) assess aquatic life in South Florida canals; (2) determine interrelationships between aquatic life in canals and other variables that affect that aquatic life; (3) evaluate the differences in conditions for South Florida canals; and (4) collect information that can be used to guide management decisions. The study is to be used as a guide in developing numeric nutrient criteria for canals.

On November 30, 2012, EPA announced its approval of FDEP's NNC. However, EPA also proposed additional regulations that would apply EPA's criteria to those waters not covered by FDEP's NNC, such as urban storm water conveyances, and many estuaries where FDEP Total Maximum Daily Loads (TMDLs) have already been adopted. Written comments on the streams (ditch) criteria are due February 1, 2013 and on the estuary criteria by February 19, 2013. EPA is holding two public meetings in Tampa on January 17th and January 18th. There are also three webinars scheduled for January 22nd, 23rd, and 24th, 2013. Staff will continue to monitor these developments.

G. On June 29, 2012, the EPA published a public notice of availability on the proposed Total Maximum Daily Loads (TMDLs) for waters and pollutants in the State of Florida. This notice included the proposed TMDL on the Southwest Fork of the Loxahatchee River and the C-18 Canal. The TMDL is for nutrients and dissolved oxygen and effects Palm Beach Country Estates, Jupiter Park of Commerce, and Egret Landing. Written comments are requested within 60 days of the notice. Staff is currently reviewing the proposed TMDL.

In addition, on July 6, 2012, FDEP announced a draft statewide TMDL for mercury and has published the document for review. Written comments will be accepted through August 27th, 2012 for the review of this document. Staff is currently reviewing this TMDL.

- H. Our office continues to monitor and participate in the activities of the Loxahatchee River Ecosystem Management Committee, the Loxahatchee River Initiative, and the Loxahatchee River Management Coordinating Council.
- I. We continue to receive, review, and comment on various permit applications for projects to be constructed within the District.
- J. We continue to provide engineering assistance to the General Manager, as needed, on operation and maintenance items, as well as landowner requests, utility requests, and inquiries from other governmental entities on issues that involve engineering support.

The following is a summary of activities and communications that were of significance during the months of February 2013 and March 2013:

1. CURRENT CAPITAL IMPROVEMENTS AND OTHER DISTRICT PROJECTS

- A. The District has received petitions from landowners to apply both OGEM and Asphalt on certain roadways within the District. The roads met the requirements to distribute a referendum to all benefited landowners. Pursuant to Board direction, staff prepared a referendum for the landowner proposed projects that was mailed August 3, 2012 with the request that the landowners submit their response to the District by September 5, 2012. On September 11, 2012, staff received the certification from the Supervisor of Elections on the results of the referendum. The majority of the landowners who voted on the following roadways were "in favor" of the proposed project for OGEM in Jupiter Farms (approximately 0.4 miles):
 - 127th Drive N. between 187th Place N. and Old Indiantown Grade
 - 90th Trail N. between 165th Place N. and 166th Way N.

In addition, the majority of the landowners who voted on the following roadways were "in favor" of the proposed project for asphalt in Palm Beach Country Estates (approximately 1.5 miles):

- 73rd Terrace N. between 155th Place N. and 159th Court N.
- 79th Terrace N. between 155th Place N. and 162nd Court N.
- 75th Way N between 163rd Court N. and 165th Street N.
- 77th Trail N. between 165th Street N. and 167th Court N.

A resolution to amend the Water Control Plan was presented to the Board of Supervisor's on October 18, 2012. As part of this resolution, staff has determined the cost estimate and the benefitted area for the project.

On January 10, 2013, a workshop was held to discuss the landowner initiated roadway program and other items. Many topics were discussed at this meeting, and some topics required further evaluation by the Board and staff.

On February 7, 2013, a continuation of the January workshop was held. The Board directed staff to prepare a letter of explanation to the landowners included within the benefitted area of the OGEM project along with an updated referendum showing the updated cost estimates. For the Asphalt project, Board directed staff to proceed with the preparation of the plan of improvement. Staff is prepared to update the Board at this month's meeting.

II. OPERATION AND MAINTENANCE

- A. National Pollutant Discharge Elimination System (NPDES) Steering Committee meetings were held on January 16th and February 20, 2013. The January meeting included an update on proposed EPA Total Maximum Daily Loads (TMDLs) for the Lake Worth Lagoon and tributaries and proposed Numeric Nutrient Criteria (NNC) for Palm Beach County Canals, Lake Worth Lagoon and the Loxahatchee River. The February meeting included final comments to EPA on proposed TMDLs and NNC and a presentation by an outside consulting team on an Alternative TMDL Approach. This year's Annual Report and the required standard operating procedures were finalized and submitted. The next Steering Committee Meeting is scheduled for March 20, 2013 and the agenda includes viewing of EXCAL Training videos for training credit.
- B. On January 24, 2008, staff met with Palm Beach County to discuss their plans for the Hatcher/Indiantown Joint Venture Property. Palm Beach County is in the planning and permitting stages of a proposed project to improve the natural areas of the property while expanding the water features. Since the January 2008 meeting, staff has participated in many meetings with Palm Beach County to evaluate the project. On February 10, 2011, a Board of Supervisors workshop was held to update the Board and public on the project.

In accordance with Board direction, staff submitted a letter of conceptual approval to Palm Beach County subject to satisfying the items that were discussed at the Board of Supervisors meeting. South Florida Water Management District (SFWMD) issued a permit for the project on July 5, 2011. Staff met with Palm Beach County on November 3, 2011 to discuss the status of the project and operation of the facilities. On February 9, 2012, staff received a draft operation plan for the Hatcher Property. Staff reviewed the operation plan, but on May 10, 2012, Palm Beach County met with staff concerning a new design proposal. At the May 17, 2012 Board Meeting, Palm Beach County presented their new proposal to the Board and staff.

Staff attended a meeting on October 16, 2012 to review a revised plan with Palm Beach County. Palm Beach County attended the November 29, 2012 Board Meeting to present the revised plan to the Board of Supervisors. At that meeting, the Board of Supervisors authorized and directed staff to prepare a letter of conceptual approval to Palm Beach County on the revised plan. Staff continues to coordinate with Palm Beach County on this project.

C. On May 1, 2012, staff met with Palm Beach County Parks and Recreation for Riverbend Park to discuss the extension of Canal 3 directly east into the park. Currently, Canal 3 goes east from Jupiter Farms Road and turns south along the District line into Riverbend Park. When it enters Riverbend Park, the canal continues through two 42-inch culverts in series before discharging into the ultimate discharge location. By extending the canal directly east instead of turning south, headloss may be reduced, which may improve flood protection.

Staff met with South Florida Water Management District for a pre-application meeting on July 10, 2012 to discuss any concerns that they may have with the project. Also, staff presented the project to the Loxahatchee River Management Coordinating Council on September 24, 2012 to inform them of the upcoming improvements and receive any comments.

Staff has submitted several permit applications and a cultural resource study has been conducted on the area to assist in the Town of Jupiter permitting process. In addition, staff has finalized a contract with a contractor for the work which is a requirement for the Town of Jupiter permit. Staff is prepared to update the Board of Supervisors on this project.

- D. SFWMD continues to operate the G-160 structure to maintain flood protection and is committed to coordinating with, and monitoring water levels at the perimeter of some of the communities adjacent to and east of the Loxahatchee Slough to determine if there are impacts to the communities resulting from the increased water levels. The monitoring wells installed in April 2010 in SIRWCD's perimeter levee for Palm Beach Country Estates are measuring surface and groundwater water levels in conjunction with the operation of the G-160 structure. Well data has been collected through the beginning of October and an interim report for the period from April 2010 September 2012 is under preparation. The interim report has not been distributed yet for review. The last stakeholder meeting was held on October 16, 2012. SFWMD has requested stakeholder input with respect to the scope of work for analysis of the data for a final report, as well as quality assurance and quality control of the data for inclusion into the DBHydro database.
- E. SFWMD's "Everglades Restoration Strategies" is a program that has been developed in order to address water quality–based effluent limits for Stormwater Treatment Areas to meet NPDES permitting requirements by EPA. As part of the program's Technical Plan, both STA expansions and Flow Equalization Basins (FEB) upstream of STAs are proposed. The plan includes designation of the L-8 Reservoir as a 45,000 ac-ft FEB for STAs 1W and 1E. As a "replacement feature", the plan proposes to acquire and construct replacement storage to capture flows from the western C-18 Basin in the Mecca vicinity and discharge those flows via "Flow-way 2" (C-18 West Canal through C-18 and Loxahatchee Slough) to the Northwest Fork of the Loxahatchee River to meet Minimum Flows and Levels. Staff will continue to follow this project and provide updates to the Board.
- F. The date for promulgation of numeric nutrient criteria (total nitrogen and total phosphorus) for lakes and flowing waters (fresh waters) was October 15, 2011; however, the date for South Florida waters, including canals, has been extended to coincide with the revised date for promulgation of numeric nutrient criteria for estuaries and coastal waters. The first notice of rulemaking for estuaries and coastal

waters was expected to be November 14, 2011 with final promulgation expected on August 15, 2012.

Staff attended a meeting conducted by the Florida Department of Environmental Protection (FDEP) on their determination of numeric nutrient criteria for the estuaries and coastal systems on August 26, 2010 and on November 17, 2010. On November 14, 2010, Environmental Protection Agency (EPA) approved the numeric nutrient criteria for fresh water and lakes. On September 29, 2011, FDEP published a draft Florida Administrative Code (F.A.C.) Chapter 62-302 regarding nutrient standards. Staff is reviewing these standards as they affect the District. The draft F.A.C. appeared before the Florida Environmental Regulation Commission (ERC). On December 8, 2011, the Florida ERC passed the Florida's numeric nutrient criteria, which include the following:

- an amendment to provide that narrative criteria will continue to apply to ditches, canals and urban storm water conveyances
- an amendment intended to limit the ability of EPA to pick and choose which provisions of the Florida rules to accept or reject.

An administrative challenge to the proposed rules has been filed by Earthjustice prior to their adoption on December 8, 2011. On June 7, 2012, an administrative law judge upheld the state's proposed new water quality rules. The rules were required ratification by the Florida Legislature, but Governor Rick Scott signed HB 7051 waiving legislative ratification of the proposed rules. After FDEP notifies the EPA of the judge's decision, EPA will have 60 days to approve the state rules and then would have to withdraw the Federal rule for the state rules to take effect.

A notice was filed in the Federal Register stating that the EPA is finalizing an extension of the July 6, 2012, effective date of the EPA NNC for six months to January 6, 2013. This will allow the EPA to review the Florida ERC approved numeric nutrient criteria. Staff has attended various workshops concerning the development of the numeric nutrient criteria and will continue to monitor the development of these criteria.

On May 15, 2012, staff attended a public workshop on Triennial Review of State Surface Water Quality Standards. This review is required by the Federal Clean Water Act to publically review, and update as necessary, Florida's water quality standards. Pursuant to federal regulations, this review is expected to happen every three years. The topics that were reviewed were Human Health-Based Criteria and Dissolved Oxygen Criteria.

On November 1, 2012, staff attended a public meeting on the South Florida Canal Aquatic Life Study being conducted by FDEP. The study objectives are to: (1) assess aquatic life in South Florida canals; (2) determine interrelationships between aquatic life in canals and other variables that affect that aquatic life; (3) evaluate the differences in conditions for South Florida canals; and (4) collect information that can be used to guide management decisions. The study is to be used as a guide in developing numeric nutrient criteria for canals.

On November 30, 2012, EPA announced its approval of FDEP's NNC. However, EPA also proposed additional regulations that would apply EPA's criteria to those

waters not covered by FDEP's NNC, such as urban storm water conveyances, and many estuaries where FDEP Total Maximum Daily Loads (TMDLs) have already been adopted. Staff will continue to monitor these developments.

G. On June 29, 2012, the EPA published a public notice of availability on the proposed Total Maximum Daily Loads (TMDLs) for waters and pollutants in the State of Florida. This notice included the proposed TMDL on the Southwest Fork of the Loxahatchee River and the C-18 Canal. The TMDL is for nutrients and dissolved oxygen and effects Palm Beach Country Estates, Jupiter Park of Commerce, and Egret Landing. Written comments are requested within 60 days of the notice. Staff is currently reviewing the proposed TMDL.

In addition, on July 6, 2012, FDEP announced a draft statewide TMDL for mercury and has published the document for review. Written comments will be accepted through August 27th, 2012 for the review of this document. Staff will continue to monitor these developments.

- H. On February 19, 2013, staff attended a meeting with SFWMD concerning three project culverts along the C-18 canal and upcoming clearing operations. Staff discussed a coordination protocol for the operation of these culverts in the event of high rainfall events. SFWMD mentioned that they would like to arrange a subsequent meeting with Palm Beach County to include their input on the operation of the culverts.
- I. Our office continues to monitor and participate in the activities of the Loxahatchee River Ecosystem Management Committee, the Loxahatchee River Initiative, and the Loxahatchee River Management Coordinating Council.
- J. We continue to receive, review, and comment on various permit applications for projects to be constructed within the District.
- K. We continue to provide engineering assistance to the General Manager, as needed, on operation and maintenance items, as well as landowner requests, utility requests, and inquiries from other governmental entities on issues that involve engineering support.

The following is a summary of activities and communications that were of significance during the month of April 2013:

I. CURRENT CAPITAL IMPROVEMENTS AND OTHER DISTRICT PROJECTS

- A. The District has received petitions from landowners to apply both OGEM and Asphalt on certain roadways within the District. The roads met the requirements to distribute a referendum to all benefited landowners. Pursuant to Board direction, staff prepared a referendum for the landowner proposed projects that was mailed August 3, 2012 with the request that the landowners submit their response to the District by September 5, 2012. On September 11, 2012, staff received the certification from the Supervisor of Elections on the results of the referendum. The majority of the landowners who voted on the following roadways were "in favor" of the proposed project for OGEM in Jupiter Farms (approximately 0.4 miles):
 - 127th Drive N. between 187th Place N. and Old Indiantown Grade
 - 90th Trail N. between 165th Place N. and 166th Way N.

In addition, the majority of the landowners who voted on the following roadways were "in favor" of the proposed project for asphalt in Palm Beach Country Estates (approximately 1.5 miles):

- 73rd Terrace N. between 155th Place N. and 159th Court N.
- 79th Terrace N. between 155th Place N. and 162nd Court N.
- 75th Way N between 163rd Court N. and 165th Street N.
- 77th Trail N. between 165th Street N. and 167th Court N.

A resolution to amend the Water Control Plan was presented to the Board of Supervisor's on October 18, 2012. As part of this resolution, staff has determined the cost estimate and the benefitted area for the project.

On January 10, 2013, a workshop was held to discuss the landowner initiated roadway program and other items. Many topics were discussed at this meeting, and some topics required further evaluation by the Board and staff.

On February 7, 2013, a continuation of the January workshop was held. The Board directed staff to prepare a letter of explanation to the landowners included within the benefitted area of the OGEM project along with an updated referendum showing the updated cost estimates. A referendum with a letter of explanation was sent to the affected landowners on March 27, 2013 with the request that the landowners submit their response to the District by April 27, 2013.

For the Asphalt project, Board directed staff to proceed with the preparation of the plan of improvement. The Plan of Improvement was submitted to the District office on March 22, 2013 for public review. A public hearing will be held at this month's board meeting. Staff is prepared to update the Board.

II. OPERATION AND MAINTENANCE

- A. A National Pollutant Discharge Elimination System (NPDES) Steering Committee meeting was held on March 20, 2013. The meeting included viewing of EXCAL Training videos for training credit. A free Stormwater Erosion and Sediment Control Inspector Training Course is being offered on May 15th and 16th in Jupiter. The next Steering Committee Meeting is scheduled for June 26, 2013 and the agenda includes a presentation by the Florida Department of Environmental Protection.
- B. On January 24, 2008, staff met with Palm Beach County to discuss their plans for the Hatcher/Indiantown Joint Venture Property. Palm Beach County is in the planning and permitting stages of a proposed project to improve the natural areas of the property while expanding the water features. Since the January 2008 meeting, staff has participated in many meetings with Palm Beach County to evaluate the project. On February 10, 2011, a Board of Supervisors workshop was held to update the Board and public on the project.

In accordance with Board direction, staff submitted a letter of conceptual approval to Palm Beach County subject to satisfying the items that were discussed at the Board of Supervisors meeting. South Florida Water Management District (SFWMD) issued a permit for the project on July 5, 2011. Staff met with Palm Beach County on November 3, 2011 to discuss the status of the project and operation of the facilities. On February 9, 2012, staff received a draft operation plan for the Hatcher Property. Staff reviewed the operation plan, but on May 10, 2012, Palm Beach County met with staff concerning a new design proposal. At the May 17, 2012 Board Meeting, Palm Beach County presented their new proposal to the Board and staff.

Staff attended a meeting on October 16, 2012 to review a revised plan with Palm Beach County. Palm Beach County attended the November 29, 2012 Board Meeting to present the revised plan to the Board of Supervisors. At that meeting, the Board of Supervisors authorized and directed staff to prepare a letter of conceptual approval to Palm Beach County on the revised plan. Staff continues to coordinate with Palm Beach County on this project.

C. On May 1, 2012, staff met with Palm Beach County Parks and Recreation for Riverbend Park to discuss the extension of Canal 3 directly east into the park.

A = COM

Currently, Canal 3 goes east from Jupiter Farms Road and turns south along the District line into Riverbend Park. When it enters Riverbend Park, the canal continues through two 42-inch culverts in series before discharging into the ultimate discharge location. By extending the canal directly east instead of turning south, headloss may be reduced, which may improve flood protection.

Staff met with South Florida Water Management District (SFWMD) for a preapplication meeting on July 10, 2012 to discuss any concerns that they may have with the project. Also, staff presented the project to the Loxahatchee River Management Coordinating Council on September 24, 2012 to inform them of the upcoming improvements and receive any comments.

Staff has submitted several permit applications and a cultural resource study has been conducted on the area to assist in the Town of Jupiter permitting process. In addition, staff has finalized a contract with a contractor for the work, which is a requirement for the Town of Jupiter permit. The project has received its SFWMD permits and Army Corp of Engineer's Permit, and the contractor is in the process of finalizing the Town of Jupiter permit. Staff is prepared to update the Board of Supervisors on this project.

- D. SFWMD continues to operate the G-160 structure to maintain flood protection and is committed to coordinating with, and monitoring water levels at the perimeter of some of the communities adjacent to and east of the Loxahatchee Slough to determine if there are impacts to the communities resulting from the increased water levels. The monitoring wells installed in April 2010 in SIRWCD's perimeter levee for Palm Beach Country Estates are measuring surface and groundwater water levels in conjunction with the operation of the G-160 structure. Well data has been collected through the beginning of October and an interim report for the period from April 2010 September 2012 is under preparation. The interim report has not been distributed yet for review. The last stakeholder meeting was held on October 16, 2012. SFWMD has requested stakeholder input with respect to the scope of work for analysis of the data for a final report, as well as quality assurance and quality control of the data for inclusion into the DBHydro database.
- E. SFWMD's "Everglades Restoration Strategies" is a program that has been developed in order to address water quality—based effluent limits for Stormwater Treatment Areas (STAs) to meet NPDES permitting requirements by EPA. As part of the program's Technical Plan, both STA expansions and Flow Equalization Basins (FEB) upstream of STAs are proposed. The plan includes designation of the L-8 Reservoir as a 45,000 ac-ft FEB for STAs 1W and 1E. As a "replacement feature", the plan proposes to acquire and construct replacement storage to capture flows from the western C-18 Basin in the Mecca vicinity and discharge those flows via "Flow-way 2" (C-18 West Canal through C-18 and Loxahatchee Slough) to the Northwest Fork of the Loxahatchee River to meet Minimum Flows and Levels. Staff will continue to follow this project and provide updates to the Board.
- F. The date for promulgation of numeric nutrient criteria (total nitrogen and total phosphorus) for lakes and flowing waters (fresh waters) was October 15, 2011; however, the date for South Florida waters, including canals, has been extended to coincide with the revised date for promulgation of numeric nutrient criteria for estuaries and coastal waters. The first notice of rulemaking for estuaries and coastal



waters was expected to be November 14, 2011 with final promulgation expected on August 15, 2012.

Staff attended a meeting conducted by the Florida Department of Environmental Protection (FDEP) on their determination of numeric nutrient criteria for the estuaries and coastal systems on August 26, 2010 and on November 17, 2010. On November 14, 2010, Environmental Protection Agency (EPA) approved the numeric nutrient criteria for fresh water and lakes. On September 29, 2011, FDEP published a draft Florida Administrative Code (F.A.C.) Chapter 62-302 regarding nutrient standards. Staff is reviewing these standards as they affect the District. The draft F.A.C. appeared before the Florida Environmental Regulation Commission (ERC). On December 8, 2011, the Florida ERC passed the Florida's numeric nutrient criteria, which include the following:

- an amendment to provide that narrative criteria will continue to apply to ditches, canals and urban storm water conveyances
- an amendment intended to limit the ability of EPA to pick and choose which provisions of the Florida rules to accept or reject.

An administrative challenge to the proposed rules has been filed by Earthjustice prior to their adoption on December 8, 2011. On June 7, 2012, an administrative law judge upheld the state's proposed new water quality rules. The rules were required ratification by the Florida Legislature, but Governor Rick Scott signed HB 7051 waiving legislative ratification of the proposed rules. After FDEP notifies the EPA of the judge's decision, EPA will have 60 days to approve the state rules and then would have to withdraw the Federal rule for the state rules to take effect.

A notice was filed in the Federal Register stating that the EPA is finalizing an extension of the July 6, 2012, effective date of the EPA NNC for six months to January 6, 2013. This will allow the EPA to review the Florida ERC approved numeric nutrient criteria. Staff has attended various workshops concerning the development of the numeric nutrient criteria and will continue to monitor the development of these criteria.

On May 15, 2012, staff attended a public workshop on Triennial Review of State Surface Water Quality Standards. This review is required by the Federal Clean Water Act to publically review, and update as necessary, Florida's water quality standards. Pursuant to federal regulations, this review is expected to happen every three years. The topics that were reviewed were Human Health-Based Criteria and Dissolved Oxygen Criteria.

On November 1, 2012, staff attended a public meeting on the South Florida Canal Aquatic Life Study being conducted by FDEP. The study objectives are to: (1) assess aquatic life in South Florida canals; (2) determine interrelationships between aquatic life in canals and other variables that affect that aquatic life; (3) evaluate the differences in conditions for South Florida canals; and (4) collect information that can be used to guide management decisions. The study is to be used as a guide in developing numeric nutrient criteria for canals.

On November 30, 2012, EPA announced its approval of FDEP's NNC. However, EPA also proposed additional regulations that would apply EPA's criteria to those waters not covered by FDEP's NNC, such as urban storm water conveyances, and

many estuaries where FDEP Total Maximum Daily Loads (TMDLs) have already been adopted.

On March 15, 2013, EPA and FDEP reached an agreement on setting NNC for Florida's waterways. The plan includes proposing state legislation and adopting additional state rules that, when combined, will eliminate the need for continued dual rulemaking and secure a single solution for Florida. The proposed legislation requires FDEP to complete its NNC rulemaking for the remaining coastal and estuarine waters by December 1, 2014 and establish interim nutrient standards until then. The legislation also includes requirements for NNC conditions in all managed conveyances and canals. Staff will continue to monitor these developments.

- G. On June 29, 2012, the EPA published a public notice of availability on the proposed Total Maximum Daily Loads (TMDLs) for waters and pollutants in the State of Florida. This notice included the proposed TMDL on the Southwest Fork of the Loxahatchee River and the C-18 Canal. The TMDL is for nutrients and dissolved oxygen and effects Palm Beach Country Estates, Jupiter Park of Commerce, and Egret Landing. In addition, on July 6, 2012, FDEP announced a draft statewide TMDL for mercury. Staff will continue to monitor these developments.
- H. On February 19, 2013, staff attended a meeting with SFWMD concerning three project culverts along the C-18 canal and upcoming clearing operations. Staff discussed a coordination protocol for the operation of these culverts in the event of high rainfall events. SFWMD mentioned that they would like to arrange a subsequent meeting with Palm Beach County to include their input on the operation of the culverts.
- I. At the March board meeting, staff was directed by the Board to investigate Palm Beach County's practices for determining the need for traffic calming devices within their rights-of way within the District's boundaries. Staff continues to investigate this matter and will report on the matter at next month's meeting.
- J. Our office continues to monitor and participate in the activities of the Loxahatchee River Ecosystem Management Committee, the Loxahatchee River Initiative, and the Loxahatchee River Management Coordinating Council.
- K. We continue to receive, review, and comment on various permit applications for projects to be constructed within the District.
- L. We continue to provide engineering assistance to the General Manager, as needed, on operation and maintenance items, as well as landowner requests, utility requests, and inquiries from other governmental entities on issues that involve engineering support.

Staff held a pre-construction meeting on April 24, 2013 with the contractor and Palm Beach County Parks and Recreation. Construction was scheduled to begin May 13, 2013. Staff is prepared to update the Board of Supervisors on this project.

D. SFWMD continues to operate the G-160 structure to maintain flood protection and is committed to coordinating with, and monitoring water levels at the perimeter of some of the communities adjacent to and east of the Loxahatchee Slough to determine if there are impacts to the communities resulting from the increased water levels. The monitoring wells installed in April 2010 in SIRWCD's perimeter levee for Palm Beach Country Estates are measuring surface and groundwater water levels in conjunction with the operation of the G-160 structure. Well data has been collected through March 2013 and a report for the period from April 2010 – March 2013 is under preparation. The last stakeholder meeting was held on October 16, 2012. SFWMD has requested stakeholder input with respect to the scope of work for analysis of the data for a final report, as well as quality assurance and quality control of the data for inclusion into the DBHydro database.

SFWMD has expressed interest in discussing the potential for reconnecting PC-10 to allow water to return to C-18 through the culvert located at the west end of SIRWCD Canal E. SFWMD would like to explore an opportunity to capture excess water from dry season storm events to contribute dry season flows to the Loxahatchee River. Staff is prepared to meet with SFWMD to discuss these items.

E. SFWMD's "Everglades Restoration Strategies" is a program that has been developed in order to address water quality-based effluent limits for Stormwater Treatment Areas (STAs) to meet NPDES permitting requirements by EPA. As part of the program's Technical Plan, both STA expansions and Flow Equalization Basins (FEB) upstream of STAs are proposed. The plan includes designation of the L-8

Reservoir as a 45,000 ac-ft FEB for STAs 1W and 1E. As a "replacement feature", the plan proposes to acquire and construct replacement storage to capture flows from the western C-18 Basin in the Mecca vicinity and discharge those flows via "Flow-way 2" (C-18 West Canal through C-18 and Loxahatchee Slough) to the Northwest Fork of the Loxahatchee River to meet Minimum Flows and Levels. Staff will continue to follow this project and provide updates to the Board.

- F. On November 14, 2010, Environmental Protection Agency (EPA) approved the numeric nutrient criteria for fresh water and lakes. On September 29, 2011, FDEP published a draft Florida Administrative Code (F.A.C.) Chapter 62-302 regarding nutrient standards. The date for promulgation of numeric nutrient criteria (total nitrogen and total phosphorus) for lakes and flowing waters (fresh waters) was October 15, 2011; however, the date for South Florida waters, including canals, has been extended to coincide with the revised date for promulgation of numeric nutrient criteria for estuaries and coastal waters. The draft F.A.C. appeared before the Florida Environmental Regulation Commission (ERC). On December 8, 2011, the Florida ERC passed Florida's numeric nutrient criteria, which include the following:
 - an amendment to provide that narrative criteria will continue to apply to ditches, canals and urban storm water conveyances
 - an amendment intended to limit the ability of EPA to pick and choose which provisions of the Florida rules to accept or reject.

An administrative challenge to the proposed rules was filed by Earthjustice prior to their adoption on December 8, 2011. On June 7, 2012, an administrative law judge upheld the state's proposed new water quality rules. The rules required ratification by the Florida Legislature; however, Governor Rick Scott signed HB 7051 waiving legislative ratification of the proposed rules. After FDEP notified the EPA of the judge's decision, EPA had 60 days to approve the state rules and then had to withdraw the Federal rule for the state rules to take effect.

A notice was filed in the Federal Register stating that the EPA was finalizing an extension of the July 6, 2012, effective date of the EPA NNC for six months to January 6, 2013. This allowed the EPA to review the Florida ERC approved numeric nutrient criteria.

On November 30, 2012, EPA announced its approval of FDEP's NNC. However, EPA also proposed additional regulations that would apply EPA's criteria to those waters not covered by FDEP's NNC, such as urban storm water conveyances, and many estuaries where FDEP Total Maximum Daily Loads (TMDLs) have already been adopted.

On March 15, 2013, EPA and FDEP reached an agreement on setting NNC for Florida's waterways. The plan includes proposing state legislation and adopting additional state rules that, when combined, will eliminate the need for continued dual rulemaking and secure a single solution for Florida. The proposed legislation requires FDEP to complete its NNC rulemaking for the remaining coastal and estuarine waters by December 1, 2014 and establish interim nutrient standards until then. The legislation also includes requirements for NNC conditions in all managed conveyances and canals. Staff will continue to monitor these developments.

- G. On June 29, 2012, the EPA published a public notice of availability on the proposed Total Maximum Daily Loads (TMDLs) for waters and pollutants in the State of Florida. This notice included the proposed TMDL on the Southwest Fork of the Loxahatchee River and the C-18 Canal. The TMDL is for nutrients and dissolved oxygen and effects Palm Beach Country Estates, Jupiter Park of Commerce, and Egret Landing. In addition, on July 6, 2012, FDEP announced a draft statewide TMDL for mercury. Staff will continue to monitor these developments.
- H. On February 19, 2013, staff attended a meeting with SFWMD concerning three project culverts along the C-18 canal and upcoming clearing operations. Staff discussed a coordination protocol for the operation of these culverts in the event of high rainfall events. SFWMD mentioned that they would like to arrange a subsequent meeting with Palm Beach County to include their input on the operation of the culverts.
- At the March board meeting, staff was directed by the Board to investigate Palm Beach County's practices for determining the need for traffic calming devices within their rights-of way within the District's boundaries. Staff continues to investigate this matter.
- J. Our office continues to monitor and participate in the activities of the Loxahatchee River Ecosystem Management Committee, the Loxahatchee River Initiative, and the Loxahatchee River Management Coordinating Council.
- K. We continue to receive, review, and comment on various permit applications for projects to be constructed within the District.
- L. We continue to provide engineering assistance to the General Manager, as needed, on operation and maintenance items, as well as landowner requests, utility requests, and inquiries from other governmental entities on issues that involve engineering support.

The following is a summary of activities and communications that were of significance during the month of June 2013:

I. CURRENT CAPITAL IMPROVEMENTS AND OTHER DISTRICT PROJECTS

- A. The District has received petitions from landowners to apply both OGEM and Asphalt on certain roadways within the District. The roads met the requirements to distribute a referendum to all benefited landowners. Pursuant to Board direction, staff prepared a referendum for the landowner proposed projects that was mailed August 3, 2012 with the request that the landowners submit their response to the District by September 5, 2012. On September 11, 2012, staff received the certification from the Supervisor of Elections on the results of the referendum. The majority of the landowners who voted on the following roadways were "in favor" of the proposed project for OGEM in Jupiter Farms (approximately 0.4 miles):
 - 127th Drive N. between 187th Place N. and Old Indiantown Grade
 - 90th Trail N. between 165th Place N. and 166th Way N.

In addition, the majority of the landowners who voted on the following roadways were "in favor" of the proposed project for asphalt in Palm Beach Country Estates (approximately 1.5 miles):

- 73rd Terrace N. between 155th Place N. and 159th Court N.
- 79th Terrace N. between 155th Place N. and 162nd Court N.
- 75th Way N between 163rd Court N. and 165th Street N.
- 77th Trail N. between 165th Street N. and 167th Court N.

A resolution to amend the Water Control Plan was presented to the Board of Supervisors on October 18, 2012. As part of this resolution, staff has determined the cost estimate and the benefitted area for the project.



On January 10, 2013, a workshop was held to discuss the landowner initiated roadway program and other items. Many topics were discussed at this meeting, and some topics required further evaluation by the Board and staff.

On February 7, 2013, a continuation of the January workshop was held. The Board directed staff to prepare a letter of explanation to the landowners included within the benefitted area of the OGEM project along with an updated referendum showing the updated cost estimates. A referendum with a letter of explanation was sent to the affected landowners on March 27, 2013 with the request that the landowners submit their response to the District by April 27, 2013. The results of the referendum were certified by the Supervisor of Elections on May 7, 2013 and both OGEM roadway segments were "in favor" of the project.

Board directed staff to proceed with the preparation of the Plan of Improvement. The Plan of Improvement was submitted to the District office on March 22, 2013 for public review and a public hearing was held on April 18, 2013.

After the public hearing, the Board directed staff to proceed with the preparation of the Engineer's Report. The Engineer's Report was submitted to the District office on May 23, 2013. Staff is preparing the necessary notices for the public hearing on the Engineer's Report for the proposed hearing to be scheduled at the next Board meeting on July 18, 2013. Staff is prepared to update the Board.

B. Staff has received requests for petitions from landowners for roadway improvement projects. Per the February 2013 workshop, staff has developed an updated petition to distribute to landowners as they request it. In addition, staff has been reviewing the limits of the roadway improvement requests before distributing the updated petition for circulation. For notification, signs are proposed to be installed stating that a petition is being circulated in the area. Staff will update the Board as valid petitions are received.

II. OPERATION AND MAINTENANCE

- A. There has not been a National Pollutant Discharge Elimination System (NPDES) Steering Committee meeting since our last report. The next Steering Committee Meeting is scheduled for June 26, 2013 and the agenda includes a presentation by the Florida Department of Environmental Protection.
- B. Since January 24, 2008, staff has been working with Palm Beach County on plans for the Hatcher/Indiantown Joint Venture Property. Palm Beach County proposes to improve the natural areas of the property while expanding the water features.

On October 16, 2012, Palm Beach County revised its original plan and attended the November 29, 2012 Board Meeting to present the revised plan to the Board of Supervisors. At that meeting, the Board of Supervisors authorized and directed staff to prepare a letter of conceptual approval to Palm Beach County on the revised plan.

On May 6, 2013, Palm Beach County received their SFWMD permit for the project and has reached out to staff to finalize their SIRWCD permit application. Staff is working with Palm Beach County on completing the application.

On March 15, 2013, EPA and FDEP reached an agreement on setting NNC for Florida's waterways. The plan includes proposing state legislation and adopting additional state rules that, when combined, will eliminate the need for continued dual rulemaking and secure a single solution for Florida. The proposed legislation requires FDEP to complete its NNC rulemaking for the remaining coastal and estuarine waters by December 1, 2014 and establish interim nutrient standards until then. The legislation also includes requirements for NNC conditions in all managed conveyances and canals. Staff will continue to monitor these developments.

G. On June 29, 2012, the EPA published a public notice of availability on the proposed Total Maximum Daily Loads (TMDLs) for waters and pollutants in the State of Florida. This notice included the proposed TMDL on the Southwest Fork of the Loxahatchee River and the C-18 Canal. The TMDL is for nutrients and dissolved

oxygen and effects Palm Beach Country Estates, Jupiter Park of Commerce, and Egret Landing. In addition, on July 6, 2012, FDEP announced a draft statewide TMDL for mercury. Staff will continue to monitor these developments.

- H. On February 19, 2013, staff attended a meeting with SFWMD concerning three project culverts along the C-18 canal and upcoming clearing operations. Staff discussed a coordination protocol for the operation of these culverts in the event of high rainfall events. SFWMD mentioned that they would like to arrange a subsequent meeting with Palm Beach County to include their input on the operation of the culverts.
- I. At the March board meeting, staff was directed by the Board to investigate Palm Beach County's practices for determining the need for traffic calming devices within their rights-of-way within the District's boundaries. In May, staff received information on the speed hump work on Brian's Way. Staff is preparing a letter to Palm Beach County per the Board's direction at the March board meeting concerning the findings of the documents. Staff continues to investigate this matter.
- J. Our office continues to monitor and participate in the activities of the Loxahatchee River Ecosystem Management Committee, the Loxahatchee River Initiative, and the Loxahatchee River Management Coordinating Council.
- K. We continue to receive, review, and comment on various permit applications for projects to be constructed within the District.
- L. We continue to provide engineering assistance to the General Manager, as needed, on operation and maintenance items, as well as landowner requests, utility requests, and inquiries from other governmental entities on issues that involve engineering support.

The following is a summary of activities and communications that were of significance during the month of July 2013:

CURRENT CAPITAL IMPROVEMENTS AND OTHER DISTRICT PROJECTS

- A. The District has received petitions from landowners to apply both OGEM and Asphalt on certain roadways within the District. The roads met the requirements to distribute a referendum to all benefited landowners. Pursuant to Board direction, staff prepared a referendum for the landowner proposed projects that was mailed August 3, 2012 with the request that the landowners submit their response to the District by September 5, 2012. On September 11, 2012, staff received the certification from the Supervisor of Elections on the results of the referendum. The majority of the landowners who voted on the following roadways were "in favor" of the proposed project for OGEM in Jupiter Farms (approximately 0.4 miles):
 - 127th Drive N. between 187th Place N. and Old Indiantown Grade
 - 90th Trail N. between 165th Place N. and 166th Way N.

In addition, the majority of the landowners who voted on the following roadways were "in favor" of the proposed project for asphalt in Palm Beach Country Estates (approximately 1.5 miles):

- 73rd Terrace N. between 155th Place N. and 159th Court N.
- 79th Terrace N. between 155th Place N. and 162nd Court N.
- 75th Way N between 163rd Court N. and 165th Street N.
- 77th Trail N. between 165th Street N. and 167th Court N.

A resolution to amend the Water Control Plan was presented to the Board of Supervisors on October 18, 2012. As part of this resolution, staff has determined the cost estimate and the benefitted area for the project.

On January 10, 2013, a workshop was held to discuss the landowner initiated roadway program and other items. Many topics were discussed at this meeting, and some topics required further evaluation by the Board and staff.

On February 7, 2013, a continuation of the January workshop was held. The Board directed staff to prepare a letter of explanation to the landowners included within the benefitted area of the OGEM project along with an updated referendum showing the updated cost estimates. A referendum with a letter of explanation was sent to the affected landowners on March 27, 2013 with the request that the landowners submit their response to the District by April 27, 2013. The results of the referendum were certified by the Supervisor of Elections on May 7, 2013 and both OGEM roadway segments were "in favor" of the project.

Board directed staff to proceed with the preparation of the Plan of Improvement. The Plan of Improvement was submitted to the District office on March 22, 2013 for public review and a public hearing was held on April 18, 2013.

After the public hearing, the Board directed staff to proceed with the preparation of the Engineer's Report. The Engineer's Report was submitted to the District office on May 23, 2013. Staff is preparing the necessary notices for the public hearing on the Engineer's Report for the proposed hearing to be scheduled at the next Board meeting on August 15, 2013.

B. Staff has received requests for petitions from landowners for roadway improvement projects. Per the February 2013 workshop, staff has developed an updated petition to distribute to landowners as they request it. In addition, staff has been reviewing the limits of the roadway improvement requests before distributing the updated petition for circulation. For notification, signs are being installed stating that a petition is being circulated in the area. Staff will update the Board as valid petitions are received.

II. OPERATION AND MAINTENANCE

- A. There has not been a National Pollutant Discharge Elimination System (NPDES) Steering Committee meeting since our last report. The June 26, 2013 Steering Committee Meeting was cancelled because the Florida Department of Environmental Protection staff were not available. The next meeting date has not been scheduled.
- B. Since January 24, 2008, staff has been working with Palm Beach County on plans for the Hatcher/Indiantown Joint Venture Property. Palm Beach County proposes to improve the natural areas of the property while expanding the water features.

On October 16, 2012, Palm Beach County revised its original plan and attended the November 29, 2012 Board Meeting to present the revised plan to the Board of Supervisors. At that meeting, the Board of Supervisors authorized and directed staff to prepare a letter of conceptual approval to Palm Beach County on the revised plan.

On May 6, 2013, Palm Beach County received their SFWMD permit for the project and has reached out to staff to finalize their SIRWCD permit application. Staff is working with Palm Beach County on completing the application.

C. On May 1, 2012, staff met with Palm Beach County Parks and Recreation representatives for Riverbend Park to discuss the extension of Canal 3 directly east into the park. Currently, Canal 3 goes east from Jupiter Farms Road and turns south along the District line into Riverbend Park. When it enters Riverbend Park, the canal continues through two 42-inch culverts in series before discharging into the ultimate discharge location. By extending the canal directly east instead of turning south, headloss may be reduced, which may improve flood protection.

Staff met with South Florida Water Management District (SFWMD) for a preapplication meeting on July 10, 2012 to discuss any concerns that they may have with the project. Also, staff presented the project to the Loxahatchee River Management Coordinating Council on September 24, 2012 to inform them of the upcoming improvements and receive any comments.

Staff has submitted several permit applications and a cultural resource study has been conducted on the area to assist in the Town of Jupiter permitting process. In addition, staff has finalized a contract with a contractor for the work, which is a requirement for the Town of Jupiter permit. The project has received permits from SFWMD, the Army Corp of Engineers, and the Town of Jupiter.

Staff held a pre-construction meeting on April 24, 2013 with the contractor and Palm Beach County Parks and Recreation. Construction began May 27, 2013 and staff continues to monitor the progress of this project.

D. SFWMD continues to operate the G-160 structure to maintain flood protection and is committed to coordinating with, and monitoring water levels at the perimeter of some of the communities adjacent to and east of the Loxahatchee Slough to determine if there are impacts to the communities resulting from the increased water levels. The monitoring wells installed in April 2010 in SIRWCD's perimeter levee for Palm Beach Country Estates are measuring surface and groundwater water levels in conjunction with the operation of the G-160 structure. Well data has been collected through March 2013 and a report for the period from April 2010 – March 2013 is under preparation. The last stakeholder meeting was held on October 16, 2012. SFWMD has requested stakeholder input with respect to the scope of work for analysis of the data for a final report, as well as quality assurance and quality control of the data for inclusion into the DBHydro database.

SFWMD has expressed interest in discussing the potential for reconnecting PC-10 to allow water to return to C-18 through the culvert located at the west end of SIRWCD Canal E. SFWMD would like to explore an opportunity to capture excess water from dry season storm events to contribute dry season flows to the Loxahatchee River. Staff is prepared to meet with SFWMD to discuss these items.

E. SFWMD's "Everglades Restoration Strategies" is a program that has been developed in order to address water quality-based effluent limits for Stormwater Treatment Areas (STAs) to meet NPDES permitting requirements by EPA. As part of the program's Technical Plan, both STA expansions and Flow Equalization Basins (FEB) upstream of STAs are proposed. The plan includes designation of the L-8 Reservoir as a 45,000 ac-ft FEB for STAs 1W and 1E. As a "replacement feature", the plan proposes to acquire and construct replacement storage to capture flows from the western C-18 Basin in the Mecca vicinity and discharge those flows via "Flow-way 2" (C-18 West Canal through C-18 and Loxahatchee Slough) to the

Northwest Fork of the Loxahatchee River to meet Minimum Flows and Levels. Staff will continue to follow this project and provide updates to the Board.

- F. On November 14, 2010, Environmental Protection Agency (EPA) approved the numeric nutrient criteria for fresh water and lakes. On September 29, 2011, FDEP published a draft Florida Administrative Code (F.A.C.) Chapter 62-302 regarding nutrient standards. The date for promulgation of numeric nutrient criteria (total nitrogen and total phosphorus) for lakes and flowing waters (fresh waters) was October 15, 2011; however, the date for South Florida waters, including canals, has been extended to coincide with the revised date for promulgation of numeric nutrient criteria for estuaries and coastal waters. The draft F.A.C. appeared before the Florida Environmental Regulation Commission (ERC). On December 8, 2011, the Florida ERC passed Florida's numeric nutrient criteria, which include the following:
 - an amendment to provide that narrative criteria will continue to apply to ditches, canals and urban storm water conveyances
 - an amendment intended to limit the ability of EPA to pick and choose which provisions of the Florida rules to accept or reject.

An administrative challenge to the proposed rules was filed by Earthjustice prior to their adoption on December 8, 2011. On June 7, 2012, an administrative law judge upheld the state's proposed new water quality rules. The rules required ratification by the Florida Legislature; however, Governor Rick Scott signed HB 7051 waiving legislative ratification of the proposed rules. After FDEP notified the EPA of the judge's decision, EPA had 60 days to approve the state rules and then had to withdraw the Federal rule for the state rules to take effect.

A notice was filed in the Federal Register stating that the EPA was finalizing an extension of the July 6, 2012, effective date of the EPA NNC for six months to January 6, 2013. This allowed the EPA to review the Florida ERC approved numeric nutrient criteria.

On November 30, 2012, EPA announced its approval of FDEP's NNC. However, EPA also proposed additional regulations that would apply EPA's criteria to those waters not covered by FDEP's NNC, such as urban storm water conveyances, and many estuaries where FDEP Total Maximum Daily Loads (TMDLs) have already been adopted.

The following is a summary of activities and communications that were of significance during the month of August 2013:

I. CURRENT CAPITAL IMPROVEMENTS AND OTHER DISTRICT PROJECTS

- A. The District has received petitions from landowners to apply both OGEM and Asphalt on certain roadways within the District. The roads met the requirements to distribute a referendum to all benefited landowners. Pursuant to Board direction, staff prepared a referendum for the landowner proposed projects that was mailed August 3, 2012 with the request that the landowners submit their response to the District by September 5, 2012. On September 11, 2012, staff received the certification from the Supervisor of Elections on the results of the referendum. The majority of the landowners who voted on the following roadways were "in favor" of the proposed project for OGEM in Jupiter Farms (approximately 0.4 miles):
 - 127th Drive N. between 187th Place N. and Old Indiantown Grade
 - 90th Trail N. between 165th Place N. and 166th Way N.

In addition, the majority of the landowners who voted on the following roadways were "in favor" of the proposed project for asphalt in Palm Beach Country Estates (approximately 1.5 miles):

- 73rd Terrace N. between 155th Place N. and 159th Court N.
- 79th Terrace N. between 155th Place N. and 162nd Court N.
- 75th Way N between 163rd Court N. and 165th Street N.
- 77th Trail N. between 165th Street N. and 167th Court N.

A resolution to amend the Water Control Plan was presented to the Board of Supervisors on October 18, 2012. As part of this resolution, staff has determined the cost estimate and the benefitted area for the project.

On January 10, 2013, a workshop was held to discuss the landowner initiated roadway program and other items. Many topics were discussed at this meeting, and some topics required further evaluation by the Board and staff.

On February 7, 2013, a continuation of the January workshop was held. The Board directed staff to prepare a letter of explanation to the landowners included within the benefitted area of the OGEM project along with an updated referendum showing the updated cost estimates. A referendum with a letter of explanation was sent to the affected landowners on March 27, 2013 with the request that the landowners submit their response to the District by April 27, 2013. The results of the referendum were certified by the Supervisor of Elections on May 7, 2013 and both OGEM roadway segments were "in favor" of the project.

The Board directed staff to proceed with the preparation of the Plan of Improvement. The Plan of Improvement was submitted to the District office on March 22, 2013 for public review and a public hearing was held on April 18, 2013.

After the public hearing, the Board directed staff to proceed with the preparation of the Engineer's Report. The Engineer's Report was submitted to the District office on May 23, 2013. At this month's meeting, a public hearing will be conducted on the Engineer's Report. At the conclusion of this meeting, the Plan of Improvement and the Engineer's Report may be approved by the Board. Staff is prepared to update the Board on the next steps of the plan.

- B. Staff has received requests for petitions from landowners for roadway improvement projects. Per the February 2013 workshop, staff has developed an updated petition to distribute to landowners as they request it. In addition, staff has been reviewing the limits of the roadway improvement requests before distributing the updated petition for circulation. For notification, signs are being installed stating that a petition is being circulated in the area. Currently, the District has received petitions from landowners to apply asphalt on certain roadways within the District. The landowners on the following roadways are petitioning to distribute a referendum for asphalt in Palm Beach Country Estates (approximately 0.75 miles):
 - 74th Avenue N. between 155th Place N. and 159th Court N.
 - 88th Trail N. between 155th Place N. and 159th Court N.

II. OPERATION AND MAINTENANCE

- A. There has not been a National Pollutant Discharge Elimination System (NPDES) Steering Committee meeting since our last report. The next meeting date has is scheduled for September 18, 2013. This will be the annual meeting with FDEP staff.
- B. Since January 24, 2008, staff has been working with Palm Beach County on plans for the Hatcher/Indiantown Joint Venture Property. Palm Beach County proposes to improve the natural areas of the property while expanding the water features.

On October 16, 2012, Palm Beach County revised its original plan and attended the November 29, 2012 Board Meeting to present the revised plan to the Board of Supervisors. At that meeting, the Board of Supervisors authorized and directed staff to prepare a letter of conceptual approval to Palm Beach County on the revised plan.

On May 6, 2013, Palm Beach County received their SFWMD permit for the project and has reached out to staff to finalize their SIRWCD permit application. On August 1, 2013, staff approved and transmitted a SIRWCD permit for the project.

C. On May 1, 2012, staff met with Palm Beach County Parks and Recreation representatives for Riverbend Park to discuss the extension of Canal 3 directly east into the park. Currently, Canal 3 goes east from Jupiter Farms Road and turns south along the District line into Riverbend Park. When it enters Riverbend Park, the canal continues through two 42-inch culverts in series before discharging into the ultimate discharge location. By extending the canal directly east instead of turning south, headloss may be reduced, which may improve flood protection.

Staff met with South Florida Water Management District (SFWMD) for a preapplication meeting on July 10, 2012 to discuss any concerns that they may have with the project. Also, staff presented the project to the Loxahatchee River Management Coordinating Council on September 24, 2012 to inform them of the upcoming improvements and receive any comments.

Staff has submitted several permit applications and a cultural resource study has been conducted on the area to assist in the Town of Jupiter permitting process. In addition, staff has finalized a contract with a contractor for the work, which is a requirement for the Town of Jupiter permit. The project has received permits from SFWMD, the Army Corp of Engineers, and the Town of Jupiter.

Staff held a pre-construction meeting on April 24, 2013 with the contractor and Palm Beach County Parks and Recreation. Construction began May 27, 2013. The contractor is stabilizing the site and staff is scheduled to conduct a preliminary walk though on the project. Staff continues to monitor the progress of this project.

D. SFWMD continues to operate the G-160 structure to maintain flood protection and is committed to coordinating with, and monitoring water levels at the perimeter of some of the communities adjacent to and east of the Loxahatchee Slough to determine if there are impacts to the communities resulting from the increased water levels. The monitoring wells installed in April 2010 in SIRWCD's perimeter levee for Palm Beach Country Estates are measuring surface and groundwater water levels in conjunction with the operation of the G-160 structure. Well data has been collected through March 2013 and a report for the period from April 2010 – March 2013 is under preparation. The last stakeholder meeting was held on October 16, 2012. SFWMD has requested stakeholder input with respect to the scope of work for analysis of the data for a final report, as well as quality assurance and quality control of the data for inclusion into the DBHydro database.

SFWMD has expressed interest in discussing the potential for reconnecting PC-10 to allow water to return to C-18 through the culvert located at the west end of SIRWCD Canal E. SFWMD would like to explore an opportunity to capture excess water from dry season storm events to contribute dry season flows to the Loxahatchee River. On July 30, 2013, staff met with SFWMD to discuss their interest and to establish flashboard settings for PC-8 in Palm Beach Country Estates. Staff is prepared to update the Board at this month's meeting.

- E. SFWMD's "Everglades Restoration Strategies" is a program that has been developed in order to address water quality–based effluent limits for Stormwater Treatment Areas (STAs) to meet NPDES permitting requirements by EPA. As part of the program's Technical Plan, both STA expansions and Flow Equalization Basins (FEB) upstream of STAs are proposed. The plan includes designation of the L-8 Reservoir as a 45,000 ac-ft FEB for STAs 1W and 1E. As a "replacement feature", the plan proposes to acquire and construct replacement storage to capture flows from the western C-18 Basin in the Mecca vicinity and discharge those flows via "Flow-way 2" (C-18 West Canal through C-18 and Loxahatchee Slough) to the Northwest Fork of the Loxahatchee River to meet Minimum Flows and Levels. Staff will continue to follow this project and provide updates to the Board.
- F. On November 14, 2010, Environmental Protection Agency (EPA) approved the numeric nutrient criteria for fresh water and lakes. On September 29, 2011, FDEP published a draft Florida Administrative Code (F.A.C.) Chapter 62-302 regarding nutrient standards. The date for promulgation of numeric nutrient criteria (total nitrogen and total phosphorus) for lakes and flowing waters (fresh waters) was October 15, 2011; however, the date for South Florida waters, including canals, has been extended to coincide with the revised date for promulgation of numeric nutrient criteria for estuaries and coastal waters. The draft F.A.C. appeared before the Florida Environmental Regulation Commission (ERC). On December 8, 2011, the Florida ERC passed Florida's numeric nutrient criteria, which include the following:
 - an amendment to provide that narrative criteria will continue to apply to ditches, canals and urban storm water conveyances
 - an amendment intended to limit the ability of EPA to pick and choose which provisions of the Florida rules to accept or reject.

An administrative challenge to the proposed rules was filed by Earthjustice prior to their adoption on December 8, 2011. On June 7, 2012, an administrative law judge upheld the state's proposed new water quality rules. The rules required ratification by the Florida Legislature; however, Governor Rick Scott signed HB 7051 waiving legislative ratification of the proposed rules. After FDEP notified the EPA of the judge's decision, EPA had 60 days to approve the state rules and then had to withdraw the Federal rule for the state rules to take effect.

A notice was filed in the Federal Register stating that the EPA was finalizing an extension of the July 6, 2012, effective date of the EPA NNC for six months to January 6, 2013. This allowed the EPA to review the Florida ERC approved numeric nutrient criteria.

On November 30, 2012, EPA announced its approval of FDEP's NNC. However, EPA also proposed additional regulations that would apply EPA's criteria to those waters not covered by FDEP's NNC, such as urban storm water conveyances, and many estuaries where FDEP Total Maximum Daily Loads (TMDLs) have already been adopted.

On March 15, 2013, EPA and FDEP reached an agreement on setting NNC for Florida's waterways. The plan includes proposing state legislation and adopting additional state rules that, when combined, will eliminate the need for continued dual rulemaking and secure a single solution for Florida. The proposed legislation requires FDEP to complete its NNC rulemaking for the remaining coastal and

estuarine waters by December 1, 2014 and establish interim nutrient standards until then. The legislation also includes requirements for NNC conditions in all managed conveyances and canals. Staff will continue to monitor these developments.

- G. On June 29, 2012, the EPA published a public notice of availability on the proposed Total Maximum Daily Loads (TMDLs) for waters and pollutants in the State of Florida. This notice included the proposed TMDL on the Southwest Fork of the Loxahatchee River and the C-18 Canal. The TMDL is for nutrients and dissolved oxygen and effects Palm Beach Country Estates, Jupiter Park of Commerce, and Egret Landing. In addition, on July 6, 2012, FDEP announced a draft statewide TMDL for mercury. Staff will continue to monitor these developments.
- H. On February 19, 2013, staff attended a meeting with SFWMD concerning three project culverts along the C-18 canal and upcoming clearing operations. Staff discussed a coordination protocol for the operation of these culverts in the event of high rainfall events. SFWMD mentioned that they would like to arrange a subsequent meeting with Palm Beach County to include their input on the operation of the culverts.
- I. At the March Board meeting, staff was directed by the Board to investigate Palm Beach County's practices for determining the need for traffic calming devices within their rights-of-way within the District's boundaries. In May, staff received information on the speed hump work on Brian's Way. Staff is preparing a letter to Palm Beach County per the Board's direction at the March board meeting concerning the findings of the documents. Staff continues to investigate this matter.
- J. Our office continues to monitor and participate in the activities of the Loxahatchee River Ecosystem Management Committee, the Loxahatchee River Initiative, and the Loxahatchee River Management Coordinating Council.
- K. We continue to receive, review, and comment on various permit applications for projects to be constructed within the District.
- L. We continue to provide engineering assistance to the General Manager, as needed, on operation and maintenance items, as well as landowner requests, utility requests, and inquiries from other governmental entities on issues that involve engineering support.
